by the Director of Finance, the Chairman of the House Ways and Means General Fund Committee, and the Chairman of the Senate Finance and Taxation General Fund Committee prior to incurring the capital outlay expenses for construction of buildings and/or related facilities."

On page 109 replace Section 17 in lieu thereof the following:

"(a) Funds appropriated from the State General Fund or earmarked state funds in this act to any state department, division, board, bureau, commission, agency, institution, or office shall not be expended for the purchase of or lease of new automotive vehicles. This prohibition shall not apply to renewals of existing leases of automotive vehicles. A state department, division, board, bureau, commission, agency, institution, or office may request to purchase or lease automotive vehicles for emergency purposes. The request shall be made in writing to the Director of Finance, the Chairman of the House Ways and Means General Fund Committee, and the Chairman of the Senate Finance and Taxation General Fund Committee. The request shall explain the nature of the automotive purchases or lease and the emergency need for the vehicle. The request shall be approved unanimously by the Director of Finance, the Chairman of the House Ways and Means General Fund Committee, and the Chairman of the Senate Finance and Taxation General Fund Committee prior to the purchase or lease of any automotive vehicle.

(b) No funds appropriated in this act shall be expended for the purpose of purchasing optional equipment on state motor vehicles that is unnecessary for the proper functioning of the automobile or safety of the driver and passengers, such as stereo equipment, power seats, leather upholstery, premium wheel covers, deluxe exterior trim, or sun roofs.
