8 SYNOPSIS: This bill makes a supplemental appropriation
9 from the Education Trust Fund to the Department of
10 Labor in the amount of \$1,600,000 for the fiscal
11 year ending September 30, 2016; makes a
12 supplemental appropriation from the Education Trust
13 Fund to the Department of Archives and History in
14 the amount of \$77,000 for the fiscal year ending
15 September 30, 2016; makes a supplemental
16 appropriation from the Education Trust Fund to the
17 Alabama Commission on Higher Education in the
18 amount of \$75,000 for the fiscal year ending
19 September 30, 2016 and makes a supplemental
20 appropriation from the Education Trust Fund to the
21 Sickle Cell Oversight and Regulatory Commission in
22 the amount of \$15,632.45.

25 TO BE ENTITLED
26 AN ACT

1 To make a supplemental appropriation from the
2 Education Trust Fund to the Department of Labor in the amount
3 of \$1,600,000 for the fiscal year ending September 30, 2016;
4 to make a supplemental appropriation from the Education Trust
5 Fund to the Department of Archives and History in the amount
6 of \$77,000 for the fiscal year ending September 30, 2016; to
7 make a supplemental appropriation from the Education Trust
8 Fund to the Alabama Commission on Higher Education in the
9 amount of \$75,000 for the fiscal year ending September 30,
10 2016 and makes a supplemental appropriation from the Education
11 Trust Fund to the Sickle Cell Oversight and Regulatory
12 Commission in the amount of \$15,632.45.

13 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

14 Section 1. In addition to all other appropriations
15 heretofore or hereafter made, there is hereby appropriated
16 \$1,600,000 from the Education Trust Fund to the Department of
17 Labor for the fiscal year ending September 30, 2016. This
18 appropriation shall be expended for a statewide longitudinal
19 database to enable the state to efficiently and accurately
20 manage, analyze and use education data to improve student
21 learning and outcomes.

22 Section 2. In addition to all other appropriations
23 heretofore or hereafter made, there is hereby appropriated
24 \$77,000 from the Education Trust Fund to the Department of
25 Archives and History for the fiscal year ending September 30,
26 2016. This appropriation shall be expended for professional
27 development and curriculum development for K-12 teachers.

1 Section 3. In addition to all other appropriations
2 heretofore or hereafter made, there is hereby appropriated
3 \$75,000 from the Education Trust Fund to the Alabama
4 Commission on Higher Education for the fiscal year ending
5 September 30, 2016. This appropriation shall be expended for
6 the Police Officer's and Firefighter's Survivor's Educational
7 Assistance Program.

8 Section 4. In addition to all other appropriations
9 heretofore or hereafter made, there is hereby appropriated
10 \$15,632.45 from the Education Trust Fund to the Sickle Cell
11 Oversight and Regulatory Commission for the fiscal year ending
12 September 30, 2016.

13 Section 5. This act shall become effective
14 immediately upon its passage and approval by the Governor, or
15 upon its otherwise becoming law.
