1 Page 1, line 27, strike "WITH" insert "THAT IS PLAYED WITHOUT THE USE OF ANY  
2 MECHANICAL, ELECTRONIC OR VIDEO DISPLAY OR SIMILAR FACSIMILE OF THE CARD,  
3 THAT HAS"

4 Line 28, strike the comma insert "AND"

5 Line 31, after "TICKETS" insert "THAT ARE PLAYED IN CONJUNCTION WITH A GAME OF  
6 BINGO DURING AN AUTHORIZED OCCASION"

7 Line 32, strike "USE OF A BINGO FLASHBOARD OR" insert "RANDOM SELECTION OF A  
8 BINGO NUMBER OR NUMBERS FROM ONE THROUGH SEVENTY-FIVE OR THE USE OF A"

9 Page 11, between lines 7 and 8, insert:

10 "Y. A CHARITY GAME TICKET SHALL NOT BE SOLD PURSUANT TO THIS ARTICLE  
11 UNLESS THE FORMAT OF THE CHARITY GAME TICKET HAS BEEN APPROVED BY THE  
12 DEPARTMENT OF GAMING. THE DEPARTMENT OF GAMING SHALL NOT APPROVE THE FORMAT  
13 OF ANY CHARITY GAME TICKET THAT WOULD RESULT IN THE REMOVAL OF THE CURRENT  
14 RESTRICTIONS SPECIFIED IN THE TRIBAL-STATE COMPACTS DUE TO CHANGES IN STATE  
15 LAW AS PROVIDED IN SECTION 5-601.02."

16 Page 14, line 39, after the "a" insert "CHARITABLE"

17 Line 41, after "year" insert "OR FOR ANY CHARITABLE QUALIFIED ORGANIZATION THAT  
18 CONDUCTS THE SALE OF CHARITY GAME TICKETS DURING THE AUTHORIZED BINGO  
19 OCCASION"

20 Page 15, strike lines 7 through 31

21 Renumber to conform

22 Line 34, strike "conduct times"

23 Line 35, strike "A."
