HOUSE OF REPRESENTATIVES AMENDMENTS TO H.B. 2238

1 Page 1, line 4, after "measures" insert ";definition"

2 Line 5, strike "SUBSECTIONS C AND D" insert "SUBSECTION C OF THIS SECTION"

3 Strike lines 23 through 25, insert "IF THE ADMINISTRATION DETERMINES AFTER THE  
4 PILOT TESTING THAT THE FRAUD REDUCTION TECHNOLOGY WOULD GENERATE SIGNIFICANT  
5 SAVINGS, THE ADMINISTRATION SHALL ENTER INTO A CONTRACT PURSUANT TO  
6 SUBSECTION A OF THIS SECTION AND THE PROCUREMENT REQUIREMENTS OF TITLE 41,  
7 CHAPTER 23.

8 D. THE ADMINISTRATION MAY REQUEST PILOT TESTING OF FRAUD REDUCTION  
9 TECHNOLOGY THAT IS DESIGNED TO IDENTIFY HEALTH CARE PROVIDERS THAT ARE  
10 ENGAGED IN FRAUDULENT ACTIVITY.

11 E. FOR THE PURPOSES OF THIS SECTION, "PILOT TESTING" MEANS A  
12 DEMONSTRATION OF FRAUD REDUCTION TECHNOLOGY BY ONE OR MORE VENDORS SUFFICIENT  
13 TO ASSESS ITS EFFECTIVENESS AND THAT IS PROVIDED AT NO COST TO THIS STATE OR  
14 THE ADMINISTRATION."

15 Line 28, after "measures" insert ";definition"

16 Line 29, strike "SUBSECTIONS C AND D" insert "SUBSECTION C OF THIS SECTION"

17 Page 2, strike lines 3 through 5, insert "IF THE DEPARTMENT DETERMINES AFTER THE  
18 PILOT TESTING THAT THE FRAUD REDUCTION TECHNOLOGY WOULD GENERATE SIGNIFICANT  
19 SAVINGS, THE DEPARTMENT SHALL ENTER INTO A CONTRACT PURSUANT TO SUBSECTION A  
20 OF THIS SECTION AND THE PROCUREMENT REQUIREMENTS OF TITLE 41, CHAPTER 23.

21 D. THE DEPARTMENT MAY REQUEST PILOT TESTING OF FRAUD REDUCTION  
22 TECHNOLOGY THAT IS DESIGNED TO IDENTIFY SERVICE PROVIDERS THAT ARE ENGAGED IN  
23 FRAUDULENT ACTIVITY.

1           E. FOR THE PURPOSES OF THIS SECTION, "PILOT TESTING" MEANS A  
2           DEMONSTRATION OF FRAUD REDUCTION TECHNOLOGY BY ONE OR MORE VENDORS SUFFICIENT  
3           TO ASSESS ITS EFFECTIVENESS AND THAT IS PROVIDED AT NO COST TO THIS STATE OR  
4           THE DEPARTMENT."
