11 HOUSEHOLD OF RESIDENCE WITHIN FOUR YEARS PRIOR"
- 12 Line 29, after the period strike remainder of line; strike lines 30 through 37
- 13 Line 38, after "RELATED" strike remainder of line; line 39, strike "THE FIRST
14 DEGREE" insert "AS IMMEDIATE FAMILY WHO HAS THE SAME HOUSEHOLD OF RESIDENCE
15 WITHIN FOUR YEARS PRIOR"
- 16 Line 43, after the period strike remainder of line; strike line 44
- 17 Page 3, strike lines 1 through 7, insert:
 - 18 "J. FOR THE PURPOSES OF THIS SECTION:
 - 19 1. "IMMEDIATE FAMILY" MEANS INDIVIDUALS WHO ARE MARRIED TO EACH OTHER
20 AND ANY CHILDREN OF THOSE INDIVIDUALS.
 - 21 2. "HOUSEHOLD OF RESIDENCE" MEANS THE PLACE OF ABODE DURING APPLICABLE
22 TIME PERIODS OR THE RESIDENCE ADDRESS USED BY AN INDIVIDUAL FOR VOTER
23 REGISTRATION OR PROPERTY TAX PURPOSES."
