SENATE AMENDMENTS TO S.B. 1017

(Reference to NRIPD amendment)

1 Page 1, lines 1, 2 and 3, strike “28-2434” insert “28-2435”

2 Line 4, strike “and” insert a comma

3 Line 5, after “28-2434” insert “and 28-2435”

4 Strike lines 7 and 8

5 Line 9, before “28-2434” insert quotation marks

6 Page 2, line 17, strike the quotation marks

7 Between lines 17 and 18, insert:

8 “28-2435. Hunger relief special plates; fund

9 A. IF, BY JUNE 30, 2010, AN ENTITY PAYS THIRTY-TWO THOUSAND DOLLARS TO  
10 THE DEPARTMENT FOR THE IMPLEMENTATION OF THIS SECTION, THE DEPARTMENT SHALL  
11 ISSUE HUNGER RELIEF SPECIAL PLATES. THE ENTITY THAT PROVIDES THE THIRTY-TWO  
12 THOUSAND DOLLARS SHALL DESIGN THE HUNGER RELIEF SPECIAL PLATES. THE DESIGN  
13 AND COLOR OF THE HUNGER RELIEF SPECIAL PLATES ARE SUBJECT TO THE APPROVAL OF  
14 THE DEPARTMENT. THE DIRECTOR MAY ALLOW A REQUEST FOR HUNGER RELIEF SPECIAL  
15 PLATES TO BE COMBINED WITH A REQUEST FOR PERSONALIZED SPECIAL PLATES. IF THE  
16 DIRECTOR ALLOWS SUCH A COMBINATION, THE REQUEST SHALL BE IN A FORM PRESCRIBED  
17 BY THE DIRECTOR AND IS SUBJECT TO THE FEES FOR THE PERSONALIZED SPECIAL  
18 PLATES IN ADDITION TO THE FEES REQUIRED FOR THE HUNGER RELIEF SPECIAL PLATES.

19 B. OF THE TWENTY-FIVE DOLLAR FEE REQUIRED BY SECTION 28-2402 FOR THE  
20 ORIGINAL SPECIAL PLATES AND FOR RENEWAL OF SPECIAL PLATES, EIGHT DOLLARS IS A  
21 SPECIAL PLATE ADMINISTRATION FEE AND SEVENTEEN DOLLARS IS AN ANNUAL DONATION.

22 C. THE DEPARTMENT SHALL DEPOSIT, PURSUANT TO SECTIONS 35-146 AND  
23 35-147, ALL SPECIAL PLATE ADMINISTRATION FEES IN THE STATE HIGHWAY FUND  
24 ESTABLISHED BY SECTION 28-6991 AND ALL DONATIONS COLLECTED PURSUANT TO THIS  
25 SECTION IN THE HUNGER RELIEF SPECIAL PLATE FUND ESTABLISHED BY SUBSECTION D  
26 OF THIS SECTION.

1 D. THE HUNGER RELIEF SPECIAL PLATE FUND IS ESTABLISHED CONSISTING OF  
2 MONIES RECEIVED PURSUANT TO THIS SECTION. THE DIRECTOR SHALL ADMINISTER THE  
3 FUND. THE FIRST THIRTY-TWO THOUSAND DOLLARS RECEIVED SHALL BE REIMBURSED TO  
4 THE ENTITY THAT PAID THE IMPLEMENTATION FEE TO THE DEPARTMENT PURSUANT TO  
5 SUBSECTION A OF THIS SECTION. MONIES IN THE FUND ARE CONTINUOUSLY  
6 APPROPRIATED. THE DIRECTOR SHALL ANNUALLY ALLOCATE ALL MONIES FROM THE FUND  
7 TO AN ORGANIZATION OPERATING STATEWIDE TO COORDINATE FOOD BANK SERVICES AND  
8 THAT IS QUALIFIED UNDER SECTION 501(c)(3) OF THE UNITED STATES INTERNAL  
9 REVENUE CODE FOR FEDERAL INCOME TAX PURPOSES. THE ORGANIZATION SHALL  
10 ESTABLISH A PROCESS TO DISTRIBUTE THE FUNDS ANNUALLY TO ORGANIZATIONS THAT  
11 PROVIDE FOOD DISTRIBUTION TO HUNGRY PEOPLE IN ARIZONA AND ARE QUALIFIED UNDER  
12 SECTION 501(c)(3) OF THE UNITED STATES INTERNAL REVENUE CODE FOR FEDERAL  
13 INCOME TAX PURPOSES. TO THE EXTENT POSSIBLE, THE DISTRIBUTING ORGANIZATION  
14 SHALL DISTRIBUTE FUNDS COLLECTED IN A GEOGRAPHIC REGION TO ORGANIZATIONS  
15 SERVING INDIVIDUALS IN THAT REGION. THE DIRECTOR SHALL FORWARD ALL MONIES  
16 DEPOSITED IN THE HUNGER RELIEF SPECIAL PLATE FUND, EXCLUDING SPECIAL PLATE  
17 ADMINISTRATION FEES, TO THE ORGANIZATION ON AN ANNUAL BASIS. THE  
18 ORGANIZATION MAY RETAIN NOT MORE THAN TEN PERCENT OF THE FUNDS FOR DOCUMENTED  
19 EXPENSES RELATED TO AN APPLICATION AND AWARD PROCESS.

20 E. ON NOTICE FROM THE DIRECTOR, THE STATE TREASURER SHALL INVEST AND  
21 DIVEST MONIES IN THE FUND AS PROVIDED BY SECTION 35-313, AND MONIES EARNED  
22 FROM INVESTMENT SHALL BE CREDITED TO THE FUND. MONIES IN THE FUND ARE EXEMPT  
23 FROM THE PROVISIONS OF SECTION 35-190 RELATING TO LAPSING OF  
24 APPROPRIATIONS.’”
