10 A. IF, BY DECEMBER 31, 2009, THIRTY-TWO THOUSAND DOLLARS IS PAID TO
11 THE DEPARTMENT FOR THE IMPLEMENTATION OF THIS SECTION, THE DEPARTMENT SHALL
12 ISSUE ARIZONA MASONIC FRATERNITY SPECIAL PLATES. THE ENTITY THAT PROVIDES
13 THE THIRTY-TWO THOUSAND DOLLARS SHALL DESIGN THE ARIZONA MASONIC FRATERNITY
14 SPECIAL PLATES. THE DESIGN AND COLOR OF THE ARIZONA MASONIC FRATERNITY
15 SPECIAL PLATES ARE SUBJECT TO THE APPROVAL OF THE DEPARTMENT. THE DIRECTOR
16 MAY ALLOW A REQUEST FOR ARIZONA MASONIC FRATERNITY SPECIAL PLATES TO BE
17 COMBINED WITH A REQUEST FOR PERSONALIZED SPECIAL PLATES. IF THE DIRECTOR
18 ALLOWS SUCH A COMBINATION, THE REQUEST SHALL BE IN A FORM PRESCRIBED BY THE
19 DIRECTOR AND IS SUBJECT TO THE FEES FOR THE PERSONALIZED SPECIAL PLATES IN
20 ADDITION TO THE FEES REQUIRED FOR THE ARIZONA MASONIC FRATERNITY SPECIAL
21 PLATES.

22 B. OF THE TWENTY-FIVE DOLLAR FEE REQUIRED BY SECTION 28-2402 FOR THE
23 ORIGINAL SPECIAL PLATES AND FOR RENEWAL OF SPECIAL PLATES, EIGHT DOLLARS IS A
24 SPECIAL PLATE ADMINISTRATION FEE AND SEVENTEEN DOLLARS IS AN ANNUAL DONATION.

25 C. THE DEPARTMENT SHALL DEPOSIT, PURSUANT TO SECTIONS 35-146 AND
26 35-147, ALL SPECIAL PLATE ADMINISTRATION FEES IN THE STATE HIGHWAY FUND
27 ESTABLISHED BY SECTION 28-6991 AND ALL DONATIONS COLLECTED PURSUANT TO THIS

1 SECTION IN THE ARIZONA MASONIC FRATERNITY SPECIAL PLATE FUND ESTABLISHED BY
2 SUBSECTION D OF THIS SECTION.

3 D. THE ARIZONA MASONIC FRATERNITY SPECIAL PLATE FUND IS ESTABLISHED
4 CONSISTING OF MONIES RECEIVED PURSUANT TO THIS SECTION. THE DIRECTOR SHALL
5 ADMINISTER THE FUND. NOT MORE THAN TEN PER CENT OF MONIES DEPOSITED IN THE
6 FUND ANNUALLY SHALL BE USED FOR THE COST OF ADMINISTERING THE FUND. MONIES
7 IN THE FUND ARE CONTINUOUSLY APPROPRIATED. THE DIRECTOR SHALL ANNUALLY
8 ALLOCATE ALL MONIES FROM THE FUND, EXCLUDING ADMINISTRATIVE FEES, TO THE
9 ENTITY THAT PROVIDES THE THIRTY-TWO THOUSAND DOLLARS TO THE DEPARTMENT
10 PURSUANT TO SUBSECTION A OF THIS SECTION. THE TRUSTEES OF THE ENTITY
11 RECEIVING THE MONIES SHALL FURTHER DISTRIBUTE THE MONIES TO STATEWIDE
12 CHARITIES THAT ARE SUPPORTED BY ARIZONA MASONS AND THAT ARE QUALIFIED UNDER
13 SECTION 501(c)(3) OF THE UNITED STATES INTERNAL REVENUE CODE FOR FEDERAL
14 INCOME TAX PURPOSES.

15 E. ON NOTICE FROM THE DIRECTOR, THE STATE TREASURER SHALL INVEST AND
16 DIVEST MONIES IN THE FUND AS PROVIDED BY SECTION 35-313, AND MONIES EARNED
17 FROM INVESTMENT SHALL BE CREDITED TO THE FUND."
