SENATE AMENDMENTS TO S.B. 1209

(Reference to PSHS amendment)

1 Page 1, strike line 1, insert:

2 *Page 1, line 7, after "NEEDS" insert "ACCORDING TO THE BEST JUDGMENT OF*
3 *THE FOSTER PARENT"*

4 *Strike lines 13 through 16, insert:*

5 *"4. WHENEVER POSSIBLE, THE CHILD SHOULD BE PLACED WITH A*
6 *FOSTER FAMILY THAT CAN ACCOMMODATE THE CHILD'S COMMUNICATION*
7 *NEEDS."*

8 Between lines 11 and 12 insert:

9 *Line 37, after "HOME" insert "THAT ARE NOT OFFENSIVE TO THE FOSTER*
10 *FAMILY"*

11 Between lines 12 and 13, insert:

12 *Line 40, after "SPACE" insert ", IN THE FOSTER HOME PREFERABLY,"*

13 Line 18, after "VISITATION" insert "; after "CHILD" insert 'IN A MANNER AND
14 LEVEL OF DETAILS DEEMED AGE APPROPRIATE BY THE FOSTER PARENT IN AGREEMENT
15 WITH THE CASEWORKER''

16 Page 2, between lines 6 and 7 insert:

17 *Line 21, after "CARE" insert "EXCEPT THE FOSTER PARENT SHALL HAVE*
18 *FULL ACCESS TO THE RECORDS TO DETERMINE IF THE CHILD WILL BE*
19 *SUCCESSFUL IN THE HOME. DURING THE FOSTER PLACEMENT, IF THE*
20 *FOSTER PARENT REQUESTS TO VIEW THE RECORD UPON EXPERIENCING*
21 *PROBLEMS WITH THE CHILD'S ADJUSTMENT, THE FULL RECORD SHALL BE*
22 *MADE AVAILABLE FOR VIEWING BY THE FOSTER PARENT."*

23 Between lines 9 and 10, insert:

24 *Line 36, after "CASEWORKER" insert ", AS IS FINANCIALLY REASONABLE*
25 *FOR THE FOSTER PARENT"*

1 Page 2, line 11, after "SECTION'" insert "; after 'RETALIATION' insert ", EXCEPT
2 THAT AN APPROPRIATE LEVEL OF PUNISHMENT MAY BE APPLIED IF THE CHILD IS PROVEN
3 TO HAVE MALICIOUSLY OR WRONGFULLY ACCUSED THE FOSTER PARENT"

4 Strike lines 12 and 13, insert:

5 *Strike lines 39, 40 and 41*

6 *Line 42, strike "ANONYMOUSLY." Insert "21"*

7 Between lines 15 and 16, insert:

8 *Line 4, after 'PLAN' insert ", AS IS FINANCIALLY REASONABLE FOR THE*
9 *FOSTER PARENT"*

10 Between lines 19 and 20, insert:

11 *"Line 17, after 'CARE' insert 'THAT IS DIRECTLY RELATED TO AN*
12 *ILLNESS, DISEASE, DEFORMITY OR OTHER PHYSICAL MALADY'*

13 *Line 19, after 'CARD' insert ", EXCEPT THAT THE FOSTER PARENT SHALL*
14 *HAVE DISCRETION TO DETERMINE IF THE CHILD IS RESPONSIBLE AND*
15 *MATURE ENOUGH TO BECOME A LICENSED DRIVER"*
