### The Amendment:

- Specifies that a DES should make reasonable efforts to place a child with their siblings if they are in out-of-home placement, guardianship or adoptive placement.
- States that if placement with siblings is not possible, DES should make reasonable efforts to maintain visitation and contact between siblings.
- Makes technical and conforming changes.

2            "D. IF A CHILD HAS BEEN REMOVED FROM THE CHILD'S HOME AND PLACED IN  
3            OUT-OF-HOME PLACEMENT, GUARDIANSHIP OR ADOPTIVE PLACEMENT, THE DEPARTMENT  
4            SHALL MAKE REASONABLE EFFORTS TO PLACE THAT CHILD WITH THE CHILD'S SIBLINGS  
5            OR, IF THAT IS NOT POSSIBLE, TO MAINTAIN FREQUENT VISITATION OR OTHER ONGOING  
6            CONTACT BETWEEN THE CHILD AND THE CHILD'S SIBLINGS UNLESS A COURT DETERMINES  
7            THAT EITHER THE PLACEMENT OR THE VISITATION OR CONTACT WOULD BE CONTRARY TO  
8            THE CHILD'S OR A SIBLING'S SAFETY OR WELL-BEING."
