

PROPOSED AMENDMENT

SENATE AMENDMENTS TO H.B. 2446

(Reference to House engrossed bill)

1 Page 5, between lines 10 and 11, insert:

2 "5. A CITY OR TOWN THAT MONITORS AN ALARM SYSTEM WITH LAW ENFORCEMENT
3 PERSONNEL."

4 Page 6, after line 45, insert:

5 "13. A COPY OF THE APPLICANT'S VALID FINGERPRINT CLEARANCE CARD.

6 14. IF THE APPLICANT IS AN INDIVIDUAL, DOCUMENTATION OF CITIZENSHIP AS
7 PROVIDED BY SECTION 41-1080."

8 Renumber to conform

9 Page 8, between lines 31 and 32, insert:

10 "E. AN ALARM BUSINESS SHALL PROVIDE A WRITTEN RESPONSE TO THE VERIFIED
11 WRITTEN COMPLAINT OF AN ALARM SUBSCRIBER WITHIN TWENTY DAYS AFTER THE ALARM
12 BUSINESS'S RECEIPT OF THE COMPLAINT. THE ALARM BUSINESS SHALL FORWARD THE
13 WRITTEN RESPONSE TO THE DEPARTMENT BY CERTIFIED MAIL OR ANY OTHER MEANS
14 PROVIDING A RECEIPT."

15 Page 9, between lines 28 and 29, insert:

16 "8. A COPY OF THE APPLICANT'S VALID FINGERPRINT CLEARANCE CARD.

17 9. DOCUMENTATION OF CITIZENSHIP AS PROVIDED BY SECTION 41-1080."

18 Renumber to conform

19 Between lines 31 and 32, insert:

20 "F. WITHIN THIRTY DAYS AFTER COMPLETING THE TRAINING REQUIREMENTS
21 PRESCRIBED IN SUBSECTION C OF THIS SECTION AND ON THE ALARM AGENT'S LICENSE
22 RENEWAL APPLICATION, THE ALARM AGENT SHALL PROVIDE DOCUMENTATION TO THE
23 DEPARTMENT CONFIRMING THE ALARM AGENT'S COMPLIANCE WITH SUBSECTION C OF THIS
24 SECTION."

25 Reletter to conform

1 Page 10, line 12, after the period strike remainder of line

2 Strike lines 13 through 17, insert "MONIES IN THE FUND ARE CONTINUOUSLY
3 APPROPRIATED AND ARE EXEMPT FROM THE PROVISIONS OF SECTION 35-190 RELATING TO
4 LAPSING OF APPROPRIATIONS.

5 D. THE DEPARTMENT SHALL SPEND MONIES IN THE FUND TO DEFRAY THE COST OF
6 THE DEPARTMENT ASSUMING THE RESPONSIBILITIES ASSOCIATED WITH THE
7 ADMINISTRATION OF LICENSING ALARM BUSINESSES AND ALARM AGENTS.

8 E. ON NOTICE FROM THE DEPARTMENT, THE STATE TREASURER SHALL INVEST AND
9 DIVEST MONIES IN THE FUND AS PROVIDED BY SECTION 35-313, AND MONIES EARNED
10 FROM INVESTMENT SHALL BE CREDITED TO THE FUND."

11 Line 21, strike "TO A PERSON WHO HAS" insert "FOR ANY OF THE FOLLOWING REASONS"

12 Strike lines 22 and 23, insert:

13 "1. SUBMITTING AN INCOMPLETE APPLICATION.

14 2. INADEQUATE PAYMENT OF FEES."

15 Page 11, between lines 21 and 22, insert:

16 "5. THE LICENSEE HAS HAD THE APPLICATION FEE RETURNED FOR ANY REASON."

17 Page 12, between lines 14 and 15, insert:

18 "44-7813. Powers and duties of the department of fire, building
19 and life safety

20 A. THE DEPARTMENT SHALL EMPLOY ANY DEPUTIES, INVESTIGATORS AND
21 ASSISTANTS AND SHALL PROCURE ALL EQUIPMENT AND RECORDS THAT ARE NECESSARY TO
22 ENFORCE THIS CHAPTER. IN ENFORCING SECTION 44-7805, THE DIRECTOR OR THE
23 DIRECTOR'S AGENTS MAY ISSUE A CITATION PURSUANT TO SECTION 13-3903 OR ISSUE A
24 CEASE AND DESIST ORDER TO ANY VIOLATOR OF THIS CHAPTER. IF THE DIRECTOR OR
25 THE DIRECTOR'S AGENTS CONDUCT INVESTIGATIONS, THE DIRECTOR OR THE DIRECTOR'S
26 AGENTS MAY RECEIVE CRIMINAL HISTORY RECORD INFORMATION FROM THE DEPARTMENT OF
27 PUBLIC SAFETY OR OTHER LAW ENFORCEMENT AGENCIES.

28 B. THE DIRECTOR OR THE DIRECTOR'S AGENTS MAY ISSUE CITATIONS TO
29 LICENSEES FOR ALLEGED VIOLATIONS OF THIS CHAPTER OR RULES ADOPTED PURSUANT TO
30 THIS CHAPTER.

1 C. AN ALARM BUSINESS'S FAILURE TO RESPOND WITHIN TWENTY DAYS TO A
2 COMPLAINT BROUGHT AGAINST THE ALARM BUSINESS IS DEEMED AN ADMISSION BY THE
3 ALARM BUSINESS OF THE CITED COMPLAINT AND THE DIRECTOR OR THE DIRECTOR'S
4 AGENTS MAY SUSPEND OR REVOKE THE LICENSE WITHOUT A HEARING."

5 Page 12, line 15, strike "44-7813" insert "44-7814"

6 Line 25, strike "44-7814" insert "44-7815"

7 Amend title to conform
