SENATE AMENDMENTS TO H.B. 2464

(Reference to proposed amendment dated 4/2/10; 10:20 a.m.)

1 Page 1, between lines 1 and 2, insert:

2 "Section 1. Section 41-511, Arizona Revised Statutes, is amended to
3 read:

4 41-511. Arizona state parks board; membership; appointment;
5 terms

6 A. There shall be an Arizona state parks board, which shall consist of
7 seven members. The state land commissioner shall be a member and the
8 remaining members, each of whom shall be a bona fide resident of ~~the~~ THIS
9 state, shall be appointed by the governor pursuant to section 38-211 TO SERVE
10 AT THE PLEASURE OF THE GOVERNOR. The appointive members shall be selected
11 because of their knowledge of and interest in outdoor activities, multiple
12 use of lands, archaeology, natural resources and the value of the historical
13 aspects of Arizona, and because of their interest in the conservation of
14 natural resources. Not less than two of the appointive members shall be
15 representative of the livestock industry, and one appointive member shall be
16 professionally engaged in general recreation work.

17 B. ~~Of the members first appointed, one shall serve for a term expiring~~
18 ~~the first Monday in January following the effective date of this article, and~~
19 ~~one each for terms expiring one, two, three, four and five years thereafter.~~
20 ~~Thereafter,~~ All appointments shall be for a full term of six years, EXCEPT
21 THAT THOSE APPOINTMENTS TO FILL A VACANCY SHALL BE FOR THE REMAINDER OF THE
22 TERM, and shall expire on the third Monday in January of the appropriate
23 year.

1 Sec. 2. Section 41-511.02, Arizona Revised Statutes, is amended to
2 read:

3 41-511.02. Director; qualifications; state historic
4 preservation officer

5 A. The ~~board~~ GOVERNOR shall ~~employ~~ APPOINT a full-time director
6 PURSUANT TO SECTION 38-211 who shall:

- 7 1. Not be one of ~~its~~ THE members OF THE BOARD.
- 8 2. Serve at the pleasure of the ~~board~~ GOVERNOR.
- 9 3. Be qualified by successful experience in administration in business
10 or in government.
- 11 4. Have a knowledge of or training in the multiple use of lands and
12 the conservation of natural resources.

13 B. The governor shall designate a full-time employee of the board with
14 professional competence and expertise in the field of historic preservation
15 as the "state historic preservation officer" to administer the state historic
16 preservation program."
