HOUSE OF REPRESENTATIVES AMENDMENTS TO H.B. 2699

HOUSE BILL 2699 (Reference to printed bill)

1 Page 1, strike lines 19 thorough 23, insert:

2 "B. A PERSON WHO IS AT LEAST EIGHTEEN YEARS OF AGE COMMITS CHILD
3 PROSTITUTION BY KNOWINGLY:

4 1. ENGAGING IN PROSTITUTION WITH A MINOR UNDER FIFTEEN YEARS OF AGE.

5 2. ENGAGING IN PROSTITUTION WITH A MINOR WHO THE PERSON KNOWS IS
6 FIFTEEN, SIXTEEN OR SEVENTEEN YEARS OF AGE.

7 3. ENGAGING IN PROSTITUTION WITH A MINOR WHO IS FIFTEEN, SIXTEEN, OR
8 SEVENTEEN YEARS OF AGE."

9 Line 38, strike "PARAGRAPH 1" insert "PARAGRAPHS 1 AND 2"

10 Strike lines 44 and 45

11 Page 2, strike lines 1 through 17, insert:

12 "E. CHILD PROSTITUTION PURSUANT TO SUBSECTION B, PARAGRAPH 1 OF THIS
13 SECTION IS A CLASS 2 FELONY AND IS PUNISHABLE PURSUANT TO SECTION 13-705."

14 Reletter to conform

15 Line 20, strike "1" insert "2"

16 Between lines 38 and 39, insert:

17 "G. CHILD PROSTITUTION PURSUANT TO SUBSECTION B, PARAGRAPH 3 OF THIS
18 SECTION IS A CLASS 6 FELONY. IF THE COURT SENTENCES THE PERSON TO A TERM OF
19 PROBATION, THE COURT SHALL ORDER THAT AS AN INITIAL TERM OF PROBATION THE
20 PERSON BE IMPRISONED IN THE COUNTY JAIL FOR NOT LESS THAN ONE HUNDRED EIGHTY
21 CONSECUTIVE DAYS. THIS JAIL TERM SHALL COMMENCE ON THE DATE OF SENTENCING.
22 THE COURT MAY SUSPEND NINETY DAYS OF THE JAIL SENTENCE IF THE PERSON HAS NOT
23 PREVIOUSLY BEEN CONVICTED OF A VIOLATIONS OF SUBSECTION B PARAGRAPHS 2 OR 3
24 OF THIS SECTION, A VIOLATION OF SECTION 13-3214 OR A VIOLATION OF ANY CITY OR
25 TOWN ORDINANCE THAT PROHIBITS PROSTITUTION AND THAT HAS THE SAME OR

1 SUBSTANTIALLY SIMILAR ELEMENTS AS SECTION 13-3214 AND THE PERSON SUCCESSFULLY
2 COMPLETES AN APPROPRIATE COURT ORDERED EDUCATION OR TREATMENT PROGRAM."

3 Page 3, lines 25 and 26, strike "IF THE OFFENSE IS A CLASS 2 FELONY" insert
4 "SUBSECTION A OR SUBSECTION B, PARAGRAPHS 1 OR 2."

5 Amend title to conform
