FLOOR AMENDMENT EXPLANATION

The amendment clarifies terminology, including that the resolution only applies to statewide initiatives.

Specifically excludes Proposition 202 approved in 2002 (tribal-state compact) from reauthorization.

Removes exception related to incidental costs of ordinary administration.

Staggers the reauthorization of initiatives approved since 1998 so that some are heard in 2012 and some are heard in 2014.
