HOUSE OF REPRESENTATIVES AMENDMENTS TO S.B. 1169

(Reference to Senate engrossed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Section 31-203, Arizona Revised Statutes, is amended to
3 read:

4 31-203. Persons disqualified as officers or employees

5 No person shall be appointed to any office or be employed by the
6 department on behalf of the state who:

7 1. Is a contractor ~~or an agent or employee of a contractor~~ FOR THE
8 DEPARTMENT, EXCEPT PURSUANT TO SECTION 31-204.

9 2. Is interested, directly or indirectly, in any business carried on
10 in connection with the department, EXCEPT PURSUANT TO SECTION 31-204.

11 3. Is found intoxicated while on duty. A single act of intoxication
12 shall justify discharge or removal.

13 Sec. 2. Section 31-204, Arizona Revised Statutes, is amended to read:

14 31-204. Interest of employee in contracts; gifts to or from
15 prisoner; penalty

16 A. An officer or employee shall not:—

17 ~~1. Be interested~~ HAVE ANY MONETARY INTEREST in any contract or
18 purchase made by anyone for or on behalf of the department, or receive,
19 directly or indirectly, compensation for services ~~other than prescribed~~
20 UNLESS APPROVED by the director.

21 ~~2. Receive any compensation whatever for any act or service the~~
22 ~~officer or employee performs for or on behalf of a contractor, or an agent or~~
23 ~~employee of a contractor.~~

24 B. An officer or employee of the department, ~~or~~ a contractor, ~~—~~ or an
25 agent or employee of a contractor, without written permission of the warden,
26 deputy warden or prison administrator, shall not make a gift or present to or
27 receive a gift or present from a prisoner, or barter or deal with a prisoner.

28 C. THIS SECTION DOES NOT PROHIBIT AN OFFICER OR EMPLOYEE OF THE
29 DEPARTMENT FROM MAINTAINING SECONDARY EMPLOYMENT IN:

1 1. ANY CORRECTIONAL FACILITY THAT IS NOT WITHIN THE PERSON'S PRIMARY
2 EMPLOYMENT.

3 2. ANY INSTITUTION OF HIGHER LEARNING AS AN ADJUNCT FACULTY MEMBER.

4 ~~C.~~ D. Any person violating this section shall be discharged from
5 office or service, and every contractor, or employee or agent of a
6 contractor, shall not be permitted to act or serve again as such contractor,
7 agent or employee."
