- 4 Page 3, line 9, after “28-1206” strike the comma insert “and”
- 5 Line 10, strike “and 28-1208”
- 6 Lines 19 and 20, strike “EITHER OF THE FOLLOWING:”
- 7 Line 21, strike “1.”
- 8 Strike lines 23 through 39
- 9 Line 40, strike “28-1207” insert “28-1206”
- 10 Page 4, line 8, strike “28-1208” insert “28-1207”

 - 19 ESTABLISHED PURSUANT TO SECTION 41-1722, THE DEPARTMENT SHALL NOT CONSIDER
 - 20 THE VIOLATION FOR THE PURPOSE OF DETERMINING WHETHER THE PERSON'S DRIVER
 - 21 LICENSE SHOULD BE SUSPENDED OR REVOKED. A COURT SHALL ONLY TRANSMIT
 - 22 ABSTRACTS OF RECORDS OF THESE VIOLATIONS TO THE DEPARTMENT FOR COMMERCIAL
 - 23 DRIVER LICENSE HOLDERS.
 - 24 B. THIS SECTION SHALL NOT BE CONSTRUED TO RESTRICT THE APPLICATION OF
 - 25 SECTION 28-1632 TO THE RENEWAL OF VEHICLE REGISTRATION.”

- 1 Page 7, strike line 25, insert “filing results in an adjudication, except if the
- 2 citation is dismissed due to lack of service.”
- 3 Lines 31 and 32, strike “seven million dollars” insert “forty per cent”
- 4 Line 34, after “citations” insert “, but not to exceed seven million dollars,”
- 5 Amend title to conform
