SENATE AMENDMENTS TO H.B. 2202

(Reference to House engrossed bill)

1 Page 1, line 9, strike "~~may~~ SHALL" insert "may"

2 Between lines 14 and 15, insert:

3 "2. THE DEPARTMENT SHALL MAKE AN INITIAL DETERMINATION AS TO THE  
4 EXISTENCE OF AN AFFECTED CLASS OF TAXPAYERS. AFTER A REVIEW OF THE  
5 TAXPAYER'S REQUEST, THE DEPARTMENT MAY DETERMINE THAT THERE HAS NOT BEEN AN  
6 EXTENSIVE MISUNDERSTANDING OR MISAPPLICATION OF THE TAX LAWS BY AN AFFECTED  
7 CLASS OF TAXPAYERS. AT THAT TIME, THE DEPARTMENT WILL NOTIFY THE TAXPAYER  
8 THAT THE REQUEST IS DENIED."

10 Line 19, after the period insert "WITHIN SIXTY DAYS AFTER CLOSE OF THE PUBLIC  
11 HEARING,"

12 Line 20, after "HEARING" strike remainder of line

13 Strike lines 21 and 22

14 Line 23, strike "DETERMINATION" insert "AND PUBLISH A PUBLIC NOTICE"; after  
15 "WEBSITE" strike remainder of line

16 Strike line 24, insert "STATING WHETHER RELIEF WILL BE GRANTED."

17 Page 2, line 5, strike "IS" insert "FILED A WRITTEN REQUEST FOR RELIEF UNDER THIS  
18 SECTION BUT HAS BEEN"

19 Line 6, strike "DESCRIBED IN" insert "THAT THE ELEMENTS OF"; after "SECTION"  
20 insert "HAVE NOT BEEN ESTABLISHED"

21 Line 7, after "TO" insert "THE SAME PROCEDURE AS PROVIDED IN"

22 Strike line 8

23 Line 9, strike "TO COMPLY WITH SECTION 42-2002 DURING THE COURSE OF ANY APPEAL."

24 Line 11, after "MATTER" insert "SOLELY"

25 Line 18, strike the first and second "THE FORM OF"

26 Line 39, after "MATTER" insert "OR TAXPAYERS THAT DIRECTLY COMPETE WITH EACH  
27 OTHER"
