5 "Sec. 24. Section 19-115, Arizona Revised Statutes, is amended to  
6 read:

7 19-115. Unlawful acts: violations: classification

8 A. Every qualified elector of the state may sign a referendum or  
9 initiative petition upon any measure which he is legally entitled to vote  
10 upon.

11 B. A person WHO knowingly ~~signing~~ SIGNS any name other than his own to  
12 a petition, except in a circumstance where he signs for a person,— in the  
13 presence of and at the specific request of such A person,— who is incapable  
14 of signing his own name,— OR PRINTING HIS OWN NAME AND ADDRESS because of  
15 physical infirmity, ~~or~~ WHO knowingly ~~signing~~ SIGNS his name more than once  
16 for the same measure,— or proposed constitutional amendment,— at one  
17 election, ~~or~~ who is not at the time of signing a qualified elector of this  
18 state OR WHO KNOWINGLY FILLS OUT THE NAME AND ADDRESS PORTION OF THE PETITION  
19 WITH THE INTENT TO COMMIT FRAUD, or any officer or person WHO knowingly  
20 ~~violating~~ VIOLATES any provision of this chapter, is guilty of a class 1  
21 misdemeanor unless another classification is specifically prescribed in this  
22 title."
