1 Page 1, line 11, after "BEEN" strike remainder of line; strike line 12, insert
2 "MADE BY A CERTIFIED PUBLIC ACCOUNTANT OR PUBLIC ACCOUNTANT WHO IS CURRENTLY
3 LICENSED BY THE ARIZONA STATE BOARD OF ACCOUNTANCY AND WHO IS NOT AN EMPLOYEE
4 OF THE DEPARTMENT. THE REPORT SHALL BE MADE IN ACCORDANCE WITH GENERALLY
5 ACCEPTED AUDITING STANDARDS AND SHALL CONTAIN FINANCIAL STATEMENTS THAT ARE
6 IN CONFORMITY WITH GENERALLY ACCEPTED ACCOUNTING PRINCIPLES. IF THE
7 DEPARTMENT HAS A COMPREHENSIVE ANNUAL FINANCIAL REPORT OF A BUDGET UNIT THAT
8 HAS BEEN PRESENTED WITH A CERTIFICATE OF ACHIEVEMENT FOR EXCELLENCE IN
9 FINANCIAL REPORTING BY THE GOVERNMENTAL FINANCE OFFICERS ASSOCIATION, THE
10 DEPARTMENT MAY POST SUCH A FINANCIAL REPORT TO SATISFY THE REQUIREMENTS OF
11 THIS SUBSECTION."

12 Page 3, strike line 13; line 14 strike "REPORTING BY THE GOVERNMENTAL FINANCE
13 OFFICERS ASSOCIATION." insert "MADE BY A CERTIFIED PUBLIC ACCOUNTANT OR
14 PUBLIC ACCOUNTANT WHO IS CURRENTLY LICENSED BY THE ARIZONA STATE BOARD OF
15 ACCOUNTANCY AND WHO IS NOT AN EMPLOYEE OF THE LOCAL GOVERNMENT. THE REPORT
16 SHALL BE MADE IN ACCORDANCE WITH GENERALLY ACCEPTED AUDITING STANDARDS AND
17 SHALL CONTAIN FINANCIAL STATEMENTS THAT ARE IN CONFORMITY WITH GENERALLY
18 ACCEPTED ACCOUNTING PRINCIPLES. IF A LOCAL GOVERNMENT HAS A COMPREHENSIVE
19 ANNUAL FINANCIAL REPORT OF A BUDGET UNIT THAT HAS BEEN PRESENTED WITH A
20 CERTIFICATE OF ACHIEVEMENT FOR EXCELLENCE IN FINANCIAL REPORTING BY THE
21 GOVERNMENTAL FINANCE OFFICERS ASSOCIATION, THE LOCAL GOVERNMENT MAY POST SUCH
22 A FINANCIAL REPORT TO SATISFY THE REQUIREMENTS OF THIS SUBSECTION."

23 Line 16, after "website" insert "OR ON A WEBSITE OF AN ASSOCIATION OF CITIES AND
24 TOWNS FOR CITIES AND TOWNS THAT DO NOT HAVE OFFICIAL WEBSITES AND ON THE
25 DEPARTMENT'S OFFICIAL INTERNET WEBSITE AS PRESCRIBED IN THIS SECTION."
