HOUSE OF REPRESENTATIVES AMENDMENTS TO H.B. 2707

I move the following SUBSTITUTE Floor Amendment to the APPROPRIATIONS Committee  
Amendment to  
HOUSE BILL 2707 (Reference to printed bill)

1 Page 2, line 35, after "THE" strike remainder of line; strike line 36, insert  
2 "COMMERCE OR ITS SUCCESSOR."

3 Page 3, between lines 4 and 5, insert:

4 "1. IN THE CASE OF A CATASTROPHIC NATURAL DISASTER, PAYMENTS OF THE  
5 EMERGENCY COSTS INCURRED BY THIS STATE. MONIES APPROPRIATED PURSUANT TO THIS  
6 PARAGRAPH:

7 (a) MAY BE USED ONLY TO PAY CURRENT EXTRAORDINARY NONRECURRING  
8 EXPENSES THAT COULD NOT HAVE BEEN REASONABLY FORESEEN OR PREVENTED AND THAT  
9 ARE REQUIRED IMMEDIATELY TO PRESERVE THE HEALTH, SAFETY AND GENERAL WELFARE  
10 OF THE PUBLIC.

11 (b) MAY NOT BE USED TO PAY THE ORDINARY COSTS OF ADMINISTERING,  
12 MAINTAINING OR OPERATING STATE GOVERNMENT OR TO MEET REVENUE OR BUDGET  
13 SHORTFALLS OF STATE GOVERNMENT."

14 Renumber to conform

15 Line 13, after "COSTS" insert ", PAID WITH STATE GENERAL FUND MONIES,"

16 Strike lines 18 through 27

17 Renumber to conform

1 Page 4, between lines 11 and 12, insert:

2 "D. IF THE LEGISLATURE PROVIDES FOR THE TRANSFER OR DIVERSION OF  
3 REVENUES, WHICH WOULD OTHERWISE HAVE BEEN CREDITED TO THE STATE GENERAL FUND,  
4 TO ANOTHER STATE FUND, THE LIMITATION ON STATE APPROPRIATIONS UNDER THIS  
5 SECTION SHALL BE COMMENSURATELY REDUCED. AN ADJUSTMENT PURSUANT TO THIS  
6 SUBSECTION SHALL BE MADE IN THE FIRST FISCAL YEAR OF THE TRANSFER OR  
7 DIVERSION AND SHALL REMAIN IN EFFECT AS LONG AS THE TRANSFER OR DIVERSION  
8 CONTINUES."
