

PROPOSED AMENDMENT

SENATE AMENDMENTS TO H.B. 2477

(Reference to House engrossed bill)

- 1 Page 1, line 8, after “THE” insert “WITNESS”
- 2 Lines 9 and 10, strike “OF THE LAW ENFORCEMENT OFFICER”
- 3 Line 11, after the period insert “UNLESS AGREED TO BY THE EMPLOYER, THE  
4 REPRESENTATIVE SHALL BE FROM THE SAME AGENCY AND SHALL NOT BE AN ATTORNEY  
5 EXCEPT THAT IF A REPRESENTATIVE FROM THE SAME AGENCY IS NOT REASONABLY  
6 AVAILABLE, WITH THE EMPLOYER’S PERMISSION, THE WITNESS LAW ENFORCEMENT  
7 OFFICER’S REPRESENTATIVE MAY BE FROM THE WITNESS LAW ENFORCEMENT OFFICER’S  
8 PROFESSIONAL MEMBERSHIP ORGANIZATION.”
- 9 Line 12, after the first “THE” insert “WITNESS”
- 10 Line 15, strike “SUBJECT OF THE INTERVIEW” insert “WITNESS LAW ENFORCEMENT  
11 OFFICER”
- 12 Line 16, after “EMPLOYER” strike remainder of line
- 13 Strike line 17, insert “OR THE WITNESS LAW ENFORCEMENT OFFICER IS RELEASED FROM  
14 THE CONFIDENTIALITY REQUIREMENTS OF THIS SECTION.”
- 15 Line 18, after the first “THE” insert “WITNESS”; strike “WITNESS”
- 16 Line 19, after “THE” insert “WITNESS”; strike “EMPLOYEE”
- 17 Line 20, strike “EMPLOYEE”
- 18 Line 21, strike “EMPLOYEE” insert “WITNESS LAW ENFORCEMENT OFFICER OR THE  
19 WITNESS LAW ENFORCEMENT OFFICER’S REPRESENTATIVE”
- 20 Line 22, strike “EMPLOYEE WHO RELEASED THE INFORMATION” insert “WITNESS LAW  
21 ENFORCEMENT OFFICER OR THE WITNESS LAW ENFORCEMENT OFFICER’S REPRESENTATIVE”
- 22 Between lines 22 and 23, insert:  
23                 “D. THIS SECTION DOES NOT PREEMPT AGREEMENTS THAT SUPPLANT, REVISE OR  
24 OTHERWISE ALTER THE PROVISIONS OF THIS SECTION, INCLUDING PREEXISTING  
25 AGREEMENTS BETWEEN THE EMPLOYER AND THE WITNESS LAW ENFORCEMENT OFFICER OR  
26 THE WITNESS LAW ENFORCEMENT OFFICER’S PROFESSIONAL MEMBERSHIP ORGANIZATION.”
