

GOWAN SUBSTITUTE FLOOR AMENDMENT
HOUSE OF REPRESENTATIVES AMENDMENTS TO H.B. 2729

I move the following SUBSTITUTE amendment to the MILITARY AFFAIRS AND PUBLIC SAFETY Committee Amendment to HOUSE BILL 2729 (Reference to printed bill)

1 Page 8, line 24, after the period strike remainder of line

2 Strike line 25

3 Page 9, between lines 27 and 28, insert:

4 "J. THIS SECTION DOES NOT:

5 1. PROHIBIT THE LAWFUL TRANSPORTING OR LAWFUL STORAGE OF ANY FIREARM
6 PURSUANT TO SECTION 12-781.

7 2. PROHIBIT A PRIVATE ENTITY OR OPERATOR OF A MULTIPURPOSE FACILITY
8 FROM LIMITING OR PROHIBITING THE POSSESSION OF FIREARMS ON PROPERTY OWNED,
9 LEASED, USED, OPERATED, CONTRACTED FOR OR CONTROLLED BY A PRIVATE ENTITY WHEN
10 NOT USED BY A GOVERNMENTAL ENTITY FOR A GOVERNMENTAL PURPOSE.

11 3. LIMIT OR PROHIBIT THE POSSESSION OF FIREARMS ON PUBLIC PROPERTY IF
12 THE PUBLIC PROPERTY IS A VEHICLE THAT IS BEING USED BY A PERSON WHO IS ACTING
13 IN THE CAPACITY OF AN EMERGENCY MEDICAL CARE TECHNICIAN AND THAT IS
14 TRANSPORTING OR MOVING A PERSON IN THIS STATE PURSUANT TO TITLE 36, CHAPTER
15 21.1."

16 Reletter to conform

17 Line 34, after the second "ACCESS" insert "TO THE PROPERTY"

18 Line 35, strike "BOTH" insert "EITHER"

19 Lines 36 and 37, strike "OR AN ARMED SECURITY OFFICER"

20 Line 38, after "(b)" insert "AN ARMED SECURITY OFFICER AND"

21 Between lines 39 and 40, insert:

22 "2. "GOVERNMENTAL PURPOSE" MEANS USED OR INTENDED TO BE USED TO
23 PERFORM GOVERNMENT FUNCTIONS ON BEHALF OF THIS STATE OR ANY AGENCY OR
24 POLITICAL SUBDIVISION OF THIS STATE. GOVERNMENTAL PURPOSE DOES NOT INCLUDE
25 THE OPERATION OF A MULTIPURPOSE FACILITY.

1 3. "MULTIPURPOSE FACILITY" MEANS ANY FACILITY THAT IS SUITABLE TO BE
2 USED TO ACCOMMODATE PROFESSIONAL SPORTING FRANCHISES, MAJOR COLLEGE FOOTBALL
3 BOWL SPONSORS, OTHER SPORTING ACTIVITIES AND ENTERTAINMENT, CULTURAL, CIVIC,
4 MEETING, TRADE SHOW OR CONVENTION EVENTS OR ACTIVITIES AND MAY INCLUDE A
5 STADIUM AND ON-SITE INFRASTRUCTURE AND RELATED COMMERCIAL USES WITHIN THE
6 FACILITY."

7 Re-number to conform

8 Page 10, line 6, strike "PUBLIC" insert "GOVERNMENTAL"

9 Line 10, strike the second "A" insert "THIS STATE OR ANY AGENCY OR"

10 Line 11, after "SUBDIVISION" insert "OF THIS STATE"

11 Amend title to conform
