HOUSE OF REPRESENTATIVES AMENDMENTS TO H.B. 2838

1 Page 12, line 11, after the period insert "THE DEPARTMENT SHALL REQUIRE THAT EACH
2 PRIVATE AGENCY LISTED ON ITS WEBSITE THAT CLAIMS TO ASSIST A WOMAN THROUGH
3 PREGNANCY INFORM ITS CLIENTS OF ALL PREGNANCY-RELATED OPTIONS, INCLUDING THE
4 RIGHT TO A LEGAL ABORTION, OR POST AT LEAST ONE CLEARLY LEGIBLE SIGN IN A
5 CONSPICUOUS WAITING ROOM LOCATION THAT STATES THAT THE AGENCY DOES NOT
6 PROVIDE ANY INFORMATION ABOUT ABORTION SERVICES."

7 Page 13, between lines 31 and 32, insert:

8 "4. A WOMAN WHO WAS NOT PROVIDED WITH INFORMATION REGARDING HER RIGHT
9 TO A LEGAL ABORTION BY A PRIVATE AGENCY THAT CLAIMS TO ASSIST A WOMAN THROUGH
10 PREGNANCY UNLESS THAT AGENCY NOTIFIED THE WOMAN PURSUANT TO SUBSECTION C,
11 PARAGRAPH 1 OF THIS SECTION THAT THE AGENCY DOES NOT PROVIDE ANY INFORMATION
12 ABOUT ABORTION SERVICES."

13 Page 16, line 13, after the period insert "THE DEPARTMENT SHALL REQUIRE THAT EACH
14 PRIVATE AGENCY LISTED ON ITS WEBSITE THAT CLAIMS TO ASSIST A WOMAN THROUGH
15 PREGNANCY INFORM ITS CLIENTS OF ALL PREGNANCY-RELATED OPTIONS, INCLUDING THE
16 RIGHT TO A LEGAL ABORTION, OR POST AT LEAST ONE CLEARLY LEGIBLE SIGN IN A
17 CONSPICUOUS WAITING ROOM LOCATION THAT STATES THAT THE AGENCY DOES NOT
18 PROVIDE ANY INFORMATION ABOUT ABORTION SERVICES."

1 Page 16, between lines 39 and 40, insert:

2 "4. A WOMAN WHO WAS NOT PROVIDED WITH INFORMATION REGARDING HER RIGHT
3 TO A LEGAL ABORTION BY A PRIVATE AGENCY THAT CLAIMS TO ASSIST A WOMAN THROUGH
4 PREGNANCY UNLESS THAT AGENCY NOTIFIED THE WOMAN PURSUANT TO SUBSECTION A,
5 PARAGRAPH 2, SUBDIVISION (b) OF THIS SECTION THAT THE AGENCY DOES NOT PROVIDE
6 ANY INFORMATION ABOUT ABORTION SERVICES."
