

PROPOSED AMENDMENT

SENATE AMENDMENTS TO S.B. 1388

(Reference to printed bill)

1 Page 1, between lines 17 and 18, insert:

2 "D. AN EMPLOYER THAT PARTICIPATES IN THE PROGRAM MUST:

3 1. BE LOCATED IN THIS STATE.

4 2. HAVE FULL-TIME POSITIONS AVAILABLE.

5 3. PROVIDE TRUE TRAINING OPPORTUNITIES THAT BENEFIT THE INDIVIDUAL AND

6 NOTIFY THE DEPARTMENT WHEN THE EMPLOYER OFFERS AN INDIVIDUAL A TRAINING
7 OPPORTUNITY UNDER THE PROGRAM.

8 4. CERTIFY TO THE DEPARTMENT THAT THE EMPLOYER WILL NOT PAY ANY WAGES
9 TO THE INDIVIDUAL.

10 5. TRAIN ONLY ONE INDIVIDUAL FOR EACH FULL-TIME POSITION THAT THE
11 EMPLOYER HAS AVAILABLE.

12 6. SIGN A WRITTEN AGREEMENT WITH EACH INDIVIDUAL WHO PARTICIPATES IN
13 THE PROGRAM AND IS TRAINED BY THE EMPLOYER.

14 7. AGREE THAT THE EMPLOYER'S CURRENT EMPLOYEES WILL NOT BE DISPLACED
15 OR LOSE ANY PROMOTION RIGHTS DUE TO AN INDIVIDUAL PARTICIPATING IN THE
16 PROGRAM.

17 8. PROVIDE ANY INFORMATION THAT IS REQUESTED BY THE DEPARTMENT.

18 E. AN INDIVIDUAL WHO PARTICIPATES IN THE PROGRAM MUST:

19 1. BE ELIGIBLE TO RECEIVE UNEMPLOYMENT COMPENSATION BENEFITS.

20 2. BE WILLING TO DEVELOP NEW STRENGTHS, SKILLS AND EXPERIENCES.

21 3. CONTINUE TO SEEK WORK UNLESS OTHERWISE EXEMPT.

Senate Amendments to S.B. 1388

1 4. CERTIFY TO THE DEPARTMENT THAT THE INDIVIDUAL UNDERSTANDS THAT
2 PARTICIPATING IN THE PROGRAM DOES NOT GUARANTEE THE INDIVIDUAL ANY FUTURE
3 EMPLOYMENT OR EXPECTATIONS OF BEING HIRED BY THE EMPLOYER.

4 5. ATTEND A MANDATORY PROGRAM ORIENTATION THAT IS CONDUCTED BY THE
5 DEPARTMENT.

6 6. PROVIDE ANY INFORMATION THAT IS REQUESTED BY THE DEPARTMENT."
