1 Page 1, line 4, after "prohibition" insert ";violation; classification"

2 Line 5, before the first "A" insert "A."

3 Line 7, after the period insert "B."; strike "THE" insert "AN"; after
4 "APPLICANT" insert "FOR A LICENSE FOR A SEARCH OR RESCUE DOG"

5 Line 9, strike "A SERVICE ANIMAL OR"

6 Between lines 9 and 10, insert:

7 "C. AN APPLICANT FOR A LICENSE FOR A SERVICE ANIMAL SHALL SIGN A
8 WRITTEN STATEMENT THAT THE DOG IS A SERVICE ANIMAL AS DEFINED IN SECTION
9 11-1024. A PERSON WHO MAKES A FALSE STATEMENT PURSUANT TO THIS SUBSECTION IS
10 GUILTY OF A PETTY OFFENSE, AND A FINE THAT SHALL NOT EXCEED FIFTY DOLLARS.
11 THE STATEMENT TO BE SIGNED SHALL BE SUBSTANTIALLY IN THE FOLLOWING FORM:

12 BY SIGNING THIS DOCUMENT, I DECLARE THAT THE DOG TO BE LICENSED
13 IS A SERVICE ANIMAL AS DEFINED IN SECTION 11-1024, ARIZONA
14 REVISED STATUTES, AND I UNDERSTAND THAT A PERSON WHO MAKES A
15 FALSE STATEMENT PURSUANT TO SECTION 9-500.32, ARIZONA REVISED
16 STATUTES, IS GUILTY OF A PETTY OFFENSE, AND IS SUBJECT TO A FINE
17 THAT DOES NOT EXCEED FIFTY DOLLARS."

18 Line 12, strike "classification"; after "exception" insert "; violation;
19 classification"

20 Page 2, line 10, strike "THE" insert "AN"; after "APPLICANT" insert "FOR A LICENSE
21 FOR A:

22 1. SEARCH OR RESCUE DOG"

23 Line 12, strike "A SERVICE ANIMAL OR"; after the period insert:

24 "2. SERVICE ANIMAL SHALL SIGN A WRITTEN STATEMENT THAT THE DOG IS A
25 SERVICE ANIMAL AS DEFINED IN SECTION 11-1024. A PERSON WHO MAKES A FALSE

8 STATUTES, IS GUILTY OF A PETTY OFFENSE, AND IS SUBJECT TO A FINE
9 THAT DOES NOT EXCEED FIFTY DOLLARS."
