- 1 Page 1, lines 7, 11 and 14, strike "IN THIS STATE"
- 2 Line 15, after "A" strike remainder of line
- 3 Line 16, strike "STATE" insert "GOVERNMENTAL AGENCY"
- 4 Line 23, strike "IN THIS STATE FOR AT LEAST ONE EMPLOYEE"
- 5 Page 2, line 22, strike the first "OR" insert "OF"
- 6 Strike lines 27 and 28, insert:

"D. A GOVERNING BODY OF A CORPORATION MAY REQUIRE APPROVAL OF THE PROCEEDINGS UNDER WHICH JOBS BONDS ARE ISSUED UNDER THIS ARTICLE. THE GOVERNING BODY MAY REQUIRE THE CORPORATION TO HAVE THE JOBS BONDS REVIEWED BY THE ATTORNEY GENERAL PURSUANT TO SECTION 35-721, SUBSECTION F. IF THE GOVERNING BODY DOES NOT REQUIRE APPROVAL OF THE PROCEEDINGS OR REQUIRE REVIEW BY THE ATTORNEY GENERAL, A WAIVER OF APPLICABLE REQUIREMENTS SHALL REMAIN IN EFFECT FOR ALL JOBS BONDS PROJECTS UNTIL THE WAIVER IS REVOKED BY THE GOVERNING BOARD."
- 15 Line 30, after "TO" insert "BENEFITTING THIS STATE BY"
- 16 Line 31, strike "BENEFIT" insert "FURTHER ADVANCE THE INTERESTS OF"
- 17 Lines 33 and 34, after "EMPLOYMENT" insert "IN THIS STATE"
- 18 Line 37, strike "A PUBLIC OFFICIAL" insert "AN OFFICER OR DIRECTOR"
- 19 Lines 38 and 40, strike "OFFICIAL" insert "OFFICER OR DIRECTOR"
- 20 Page 3, line 20, after "OR" insert "OTHER"; strike "SUBDIVISION" insert "SUBDIVISIONS"; strike "IS" insert "ARE"
- 22 Line 25, strike the first "A" insert "ANY OTHER"
- 23 Line 26, strike the "OR TAXING POWERS"; after the comma insert "OR THE GENERAL CREDIT OR TAXING POWER OF"; strike the third "THE" insert "OTHER"
- 25 Line 27, strike "SUBDIVISION" insert "SUBDIVISIONS"
- 26 Line 41, strike "THIRTY" insert "NINETY"
- 27 Page 4, lines 2 and 3, strike "THIRTY" insert "NINETY"
