HOUSE OF REPRESENTATIVES AMENDMENTS TO H.B. 2624

I move the following SUBSTITUTE Floor amendment to the ENERGY, ENVIRONMENT AND NATURAL RESOURCES Committee amendment to
HOUSE BILL 2624(Reference to printed bill)

1 Page 1, between lines 7 and 8, insert:

2 "1. THE YARNELL HILL MEMORIAL SITE BOARD RECOMMENDS THAT THE STATE
3 PARKS BOARD PURCHASE THE LAND FOR THE MEMORIAL SITE.

4 Renumber to conform

5 Between lines 11 and 12, insert:

6 "4. THE YARNELL HILL MEMORIAL SITE BOARD SECURES THE NECESSARY
7 PERMISSIONS FOR INDIVIDUALS TO VISIT THE MEMORIAL."

8 Between lines 31 and 32, insert:

9 "6. A REPRESENTATIVE FROM THE YARNELL FIRE DISTRICT, WHO IS APPOINTED
10 BY THE SPEAKER OF THE HOUSE OF REPRESENTATIVES.

11 7. A REPRESENTATIVE FROM THE YARNELL CHAMBER OF COMMERCE, WHO IS
12 APPOINTED BY THE SPEAKER OF THE HOUSE OF REPRESENTATIVES."

14 Lines 45 and 46, strike "SPEAKER OF THE HOUSE OF REPRESENTATIVES" insert
15 "PRESIDENT OF THE SENATE"

16 Page 2, line 2, strike "OCCURED" insert "OCCURRED"

17 Line 9, strike "10" insert "12"

18 Line 13, after "1." insert "DETERMINE WHETHER TO"

19 Line 14, after "FIRE" insert "AT THE LOCATION WHERE THE CREW LOST THEIR LIVES.

20 IF THE BOARD DETERMINES THAT THE SITE SHOULD BE MEMORIALIZED, THE BOARD SHALL
21 ESTABLISH THE MEMORIAL AND APPROVE ITS DESIGN AND CONSTRUCTION.

22 2. DETERMINE WHETHER THE STATE PARKS BOARD OR A PRIVATE PARTY SHOULD
23 PURCHASE THE LAND FOR THE MEMORIAL SITE.

24 3. WORK WITH INTERESTED PARTIES TO DESIGN AND CONSTRUCT THE MEMORIAL.

25 4. PLAN FOR AND SECURE THE NECESSARY PERMISSIONS FOR INDIVIDUALS TO
26 VISIT THE MEMORIAL.

1 5. SEEK TO MINIMIZE THE USE OF STATE GENERAL FUNDS FOR THE PURCHASE,
2 MAINTENANCE AND PRESERVATION OF THE MEMORIAL."

4 Page 2, strike lines 22 and 23

5 Line 32, after "OF" insert "PURCHASING LAND FOR THE MEMORIAL,"

6 Line 44, after the period, insert "Any amounts not used for the purchase shall
7 revert to the state general fund."
