FLOOR AMENDMENT EXPLANATION

- Adds to SB1488 that any one-time FY 2015 incremental funding for district sponsored charter schools that began initial operations during FY 2014 must be specified in the district sponsored charter schools line item funding for FY 2014 in the General Appropriations Act (HB 2703).
- Contains a conditional enactment clause stating the previous requirement only becomes effective if *SB1488 K-12 education; budget reconciliations; 2014-2015* and *HB2703 2014-2015; general appropriations* become law.

1 Page 1, between lines 1 and 2, insert:

2 "Section 1. Senate Bill 1488, section 22, fifty-first legislature,
3 second regular session, as transmitted to the governor, is amended to read:

4 Sec. 22. District-sponsored charter schools: fiscal years
2013-2014 and 2014-2015

5 Notwithstanding section 15-183, Arizona Revised Statutes, as amended by
6 this act, a school district governing board that granted a charter to a new
7 charter school that began initial operations as a charter school after June
8 30, 2013 but before July 1, 2014 or that converted an existing district
9 public school to a charter school that began initial operations as a charter
10 school after June 30, 2013 but before July 1, 2014 may continue to sponsor
11 and operate that charter school only through fiscal year 2014-2015.

12 IN FISCAL YEAR 2014-2015, THE INCREMENTAL FUNDING FOR A NEW CHARTER SCHOOL THAT
13 BEGAN INITIAL OPERATIONS AS A CHARTER SCHOOL AFTER JUNE 30, 2013 BUT BEFORE
14 JULY 1, 2014 OR A CHARTER SCHOOL THAT WAS CONVERTED FROM AN EXISTING DISTRICT
15 PUBLIC SCHOOL TO A CHARTER SCHOOL THAT BEGAN INITIAL OPERATIONS AS A CHARTER
16 SCHOOL AFTER JUNE 30, 2013 BUT BEFORE JULY 1, 2014 MUST BE AS PRESCRIBED IN
17 THE SCHOOL YEAR 2013-2014 SCHOOL DISTRICT CHARTER SCHOOL CONVERSIONS LINE
18 ITEM AND THE RELATED FOOTNOTE CONTAINED IN HOUSE BILL 2703, FIFTY-FIRST
19 LEGISLATURE, SECOND REGULAR SESSION, RELATING TO APPROPRIATIONS AND BUDGET
20 REDUCTIONS, LIMITATIONS AND TRANSFERS FOR THE DIFFERENT DEPARTMENTS OF THE
21 STATE, FOR STATE INSTITUTIONS AND FOR PUBLIC SCHOOLS FOR FISCAL YEAR
22 2014-2015."

2 "Sec. 4. Conditional enactment

3 Section 1 of this act does not become effective unless Senate Bill
4 1488, fifty-first legislature, second regular session, relating to
5 kindergarten through grade twelve budget reconciliation, and House Bill 2703,
6 fifty-first legislature, second regular session, relating to appropriations
7 and budget reductions, limitations and transfers for the different
8 departments of the state, for state institutions and for public schools for
9 fiscal year 2014-2015, become law."
