- 17 Line 17, strike "~~remedial or mitigative~~" insert "remedial, ~~or~~ mitigative OR"; strike "action" insert "ACTIONS OR CONTROLS AS SPECIFIED IN THE PERMIT OR PERFORM CORRECTIVE ACTION AS"
- 20 Page 9, line 28, after "APPLICANT" insert "OR PERMITTEE"
- 21 Line 30, after "APPLICANT" insert "OR PERMITTEE"
- 22 Between lines 42 and 43, insert:

"M. WITH THE CONSENT OF THE APPLICANT OR PERMITTEE, THE DIRECTOR MAY INCLUDE IN AN AQUIFER PROTECTION PERMIT AS A CONDITION THE MITIGATION MEASURES AUTHORIZED UNDER SECTION 49-286 INSTEAD OF ISSUING A MITIGATION ORDER UNDER SECTION 49-286."
