## FLOOR AMENDMENT EXPLANATION

---

---

- Aligns statutory timeframe requirements with common county election department timeframe requirements regarding when school district override elections must be ordered and when districts must submit proposed ballot language to Legislative Council for approval.
- Requires districts to order override elections no later than 120 days before the proposed election.
- Requires proposed ballot language for capital overrides, class B bonds and impact aid revenue bonds to be submitted to Legislative Council for approval no later than 119 days before the election and modifies other associated timelines.
- Includes references to officers in charge of elections other than county school superintendents.
