Bill Number: **HB 2272**

Borrelli Floor Amendment

As amended by the Committee on Military Affairs and Public Safety, HB 2272 allows a law enforcement officer who is a member of PSPRS to purchase a firearm issued by his or her employer at a price determined by the administrator of the employer agency.

The Borrelli substitute floor amendment to the Committee on Military Affairs and Public Safety amendment expands the above provision to include officers who are members of ASRS and CORP and defines *officer* as an AZPOST-certified law enforcement officer, a detention or corrections officer, a county deputy sheriff, a municipal police officer, or a probation officer.
