Bill Number: **SB 1162**

Petersen Floor Amendment

Senate Bill 1162 establishes a licensing moratorium for home-based businesses during a *state of emergency* or a *state of war emergency*.

PETERSEN Floor Amendment

Establishes a licensing moratorium for home-based businesses while the statewide unemployment rate exceeds 10%, according to the U.S. Department of Labor, Bureau of Labor Statistics.

Includes the Amendment adopted in the House Committee on Commerce.

- 8 TEN PERCENT"
- 9 Line 12, after "LAW" insert "BEFORE THE HOME-BASED BUSINESS ENGAGES IN ANY
- 10 FURTHER CONDUCT OF BUSINESS"
- 11 Between lines 12 and 13, insert:
- 12 "B. THIS SECTION DOES NOT EXEMPT ANY HOME-BASED BUSINESS FROM ANY
- 13 OTHER APPLICABLE LAW AND ORDINANCE."
- 14 Reletter to conform
- 15 Between lines 18 and 19, insert:
- 16 "2. "HOME-BASED BUSINESS" MEANS ANY BUSINESS FOR THE LIMITED
- 17 MANUFACTURE, PROVISION OR SALE OF GOODS OR SERVICES THAT IS OWNED AND
- 18 OPERATED BY THE OWNER OR TENANT OF THE RESIDENTIAL PROPERTY."

- 20 Amend title to conform
