Brophy McGee Floor Amendment

FLOOR AMENDMENT EXPLANATION

SB 1201 directs the Governor to appoint the members of the Arizona Historical Society (AHS) Board of Directors (Board).

Your 19-line floor amendment to SB 1201 makes the following changes:

1. Requires all members of the Board to be members of AHS.
2. Requires the Board to consist of 24 members, 12 of which are appointed by the Governor and 12 of which are elected by the members of AHS.
3. Requires the Board to consist of at least six members from a county with a population less than 900,000.
 - a. Three of these members are appointed by the Governor and three members are elected by AHS.
4. Specifies that current Board members may continue to serve until expiration of their term of office.

BROPHY MCGEE FLOOR AMENDMENT

HOUSE OF REPRESENTATIVES AMENDMENTS TO S.B. 1201

(Reference to Senate engrossed bill)

1 Page 1, line 16, after "HISTORY" insert "AND SHALL BE MEMBERS OF THE ARIZONA
2 HISTORICAL SOCIETY. TWELVE MEMBERS OF THE BOARD SHALL BE ELECTED BY THE
3 MEMBERS OF THE SOCIETY AT TIMES AND BY METHODS THE BYLAWS OF THE SOCIETY
4 PRESCRIBE"; after "AND" insert "TWELVE MEMBERS OF THE BOARD"

5 Line 21, after "FOLLOWING" insert a colon; strike lines 22 through 33, insert:

6 "1. AT LEAST THREE MEMBERS FROM A COUNTY WITH A POPULATION OF LESS
7 THAN NINE HUNDRED THOUSAND PERSONS WHO ARE APPOINTED BY THE GOVERNOR.

8 2. AT LEAST THREE MEMBERS FROM A COUNTY WITH A POPULATION OF LESS THAN
9 NINE HUNDRED THOUSAND PERSONS WHO ARE ELECTED BY THE MEMBERS OF THE SOCIETY."

10 Page 2, after line 35, insert:

11 "Sec. 2. Terms of the board

12 Notwithstanding section 41-821, Arizona Revised Statutes, as amended by
13 this act, a person who is serving as a member of the Arizona historical
14 society board of directors on the effective date of this act may continue to
15 serve until expiration of the current term of office. On the expiration of
16 the term, the members shall be elected by the members of the Arizona
17 historical society or appointed by the governor pursuant to section 41-821,
18 Arizona Revised Statutes, as amended by this act."
