SB 1240 reorganizes and makes changes to statues relating to transport, sale, tax, acquisition and possession of tobacco products.

The two page Mitchell Floor Amendment dated 03/10/2015 at 4:14 p.m.:

- Provides that the imposed tax must be refunded within six months after a distributor returns a luxury to the manufacturer or importer, and proof of the return is made to the Department of Revenue (department).
- Clarifies that record documentation and invoices regarding tobacco manufacturers, importers, distributors and retailers must be in a format prescribed by the department.
- Requires a distributor to include referenced dates of distribution and invoice numbers from the applicable invoice documentation upon filing a return.
- Authorizes the *ounces of roll-your-own tobacco* that were distributed to be recorded and included in the tax return file.
- Makes technical and conforming changes.

"Sec. 12. Section 42-3008, Arizona Revised Statutes, is amended to read:

42-3008. Refunds; definitions

- A. Except as provided in subsection C of this section, the tax imposed by this chapter upon ON any luxury shall be refunded when the amount of the tax has been paid and when either ONE OF THE FOLLOWING APPLIES:
- 1. Proof is made to the department that the luxuries were exported from this state or that the stamps have been affixed to luxuries $\frac{\text{upon}}{\text{oN}}$ which stamps are not required.
- 2. Proof is made to the department that the luxury becomes unfit for sale due to breakage or spoilage within either six months from the date that the distributor originally receives the luxury for sale or two months from the date that the luxury was returned to the distributor by a retailer, whichever occurs later.
- 3. WITHIN SIX MONTHS AFTER A DISTRIBUTOR RETURNS A LUXURY TO THE MANUFACTURER OR IMPORTER, PROOF OF THE RETURN IS MADE TO THE DEPARTMENT.
- B. The manner of making proof shall be in accordance with rules adopted by the department.
- C. The department shall not refund the tax for stamps that are affixed to luxuries that are deemed contraband under this chapter.
- D. Except as otherwise provided in section 42-1123, interest is calculated sixty days after receipt by the department of a claim for refund under this section.
 - E. For the purposes of this section:
- 1. "Breakage" means damage to the outer wrapping or container of a tobacco product.
- 2. "IMPORTER" AND "MANUFACTURER" HAVE THE SAME MEANINGS PRESCRIBED IN SECTION 42-3451.
