SENATE AMENDMENTS TO S.B. 1274

(Reference to printed bill)

1 Page 1, between lines 1 and 2, insert:

2 "Section 1. Section 28-2051, Arizona Revised Statutes, is amended to
3 read:

4 28-2051. Application for certificate of title; vision screening
5 test

6 A. A person shall apply to the department on a form prescribed or
7 authorized by the department for a certificate of title to a motor vehicle,
8 trailer or semitrailer. The person shall make the application within fifteen
9 days after the purchase or transfer of the vehicle, trailer or semitrailer
10 except that a licensed motor vehicle dealer shall make the application within
11 thirty days after the purchase or transfer. All transferees shall sign the
12 application, except that one transferee may sign the application if both of
13 the following apply:

14 1. The application is for the purposes of converting an out-of-state
15 certificate of title to a certificate of title issued pursuant to this
16 article.

17 2. The ownership or legal status of the motor vehicle, trailer or
18 semitrailer does not change.

19 B. The application shall contain:

20 1. The transferee's full name and either the driver license number of
21 the transferee or a number assigned by the department.

22 2. The transferee's complete residence address.

23 3. A brief description of the vehicle to be titled.

24 4. The name of the manufacturer of the vehicle.

25 5. The serial number of the vehicle.

26 6. The last license plate number if applicable and if known and the
27 state in which the license plate number was issued.

1 7. If the application is for a certificate of title to a new vehicle,
2 the date of sale by the manufacturer or dealer to the person first operating
3 the vehicle.

4 8. If the application is in the name of a lessor:
5 (a) The lessor shown on the application as the owner or transferee.
6 (b) At the option of the lessor, the lessee shown on the application
7 as the registrant.

8 (c) The address of either the lessor or lessee.
9 (d) The signature of the lessor.
10 9. If the application is for a certificate of title to a specially
11 constructed, reconstructed or foreign vehicle, a statement of that fact. For
12 the purposes of this paragraph, "specially constructed vehicle" means a
13 vehicle not originally constructed under a distinctive name, make, model or
14 type by a generally recognized manufacturer of vehicles.

15 10. If an applicant rents or intends to rent the vehicle without a
16 driver, a statement of that fact.

17 11. Other information required by the department.
18 C. Unless subsection B, paragraph 8 of this section applies, on
19 request of an applicant, the department shall allow the applicant to provide
20 on the title of a motor vehicle, trailer or semitrailer a post office box
21 address that is regularly used by the applicant.

22 D. A person shall submit the following information with an application
23 for a certificate of title:

24 1. To a vehicle previously registered:
25 (a) The odometer mileage disclosure statement prescribed by section
26 28-2058.
27 (b) If the applicant is applying for title pursuant to section
28 28-2060, the applicant's statement of the odometer reading as of the date of
29 application.

30 2. To a new vehicle:
31 (a) **EITHER OF THE FOLLOWING:**

1 (i) A certificate or electronic title from the manufacturer showing
2 the date of sale to the dealer or person first receiving the vehicle from the
3 manufacturer. Before the department issues a certificate of title to a new
4 vehicle, a certificate or electronic title from the manufacturer shall be
5 surrendered to the department.

6 (ii) OTHER DOCUMENTATION AS APPROVED BY THE DIRECTOR SHOWING THAT THE
7 DATE OF SALE TO THE DEALER OR PERSON FIRST RECEIVING THE VEHICLE FROM THE
8 MANUFACTURER.

9 (b) The name of the dealer or person.
10 (c) A description sufficient to identify the vehicle.
11 (d) A statement certifying that the vehicle was new when sold.
12 (e) If sold through a dealer, a statement by the dealer certifying
13 that the vehicle was new when sold to the applicant.

14 E. The department may request that an applicant who appears in person
15 for a certificate of title of a motor vehicle, trailer or semitrailer
16 satisfactorily complete the vision screening test prescribed by the
17 department."
