SENATE AMENDMENTS TO S.B. 1287

(Reference to printed bill)

1 Page 1, between lines 1 and 2, insert:

2 "Section 1. Section 16-515, Arizona Revised Statutes, is amended to
3 read:

4 16-515. "Seventy-five foot limit" notices; posting; violation;
5 classification

6 A. Except as prescribed in this section and section 16-580, a person
7 shall not be allowed to remain inside the seventy-five foot limit while the
8 polls are open, except for the purpose of voting, and except the election
9 officials, one representative at any one time of each political party
10 represented on the ballot who has been appointed by the county chairman of
11 that political party and the challengers allowed by law, and no
12 electioneering may occur within the seventy-five foot limit. Voters having
13 cast their ballots shall promptly move outside the seventy-five foot limit.

14 B. The board of supervisors shall furnish, with the ballots for each
15 polling place, three notices, printed in letters not less than two inches
16 high, with the heading: "Seventy-five foot limit" and underneath that
17 heading the following:

18 No person shall be allowed to remain inside these limits while
19 the polls are open, except for the purpose of voting, and except
20 the election officials, one representative at any one time of
21 each political party represented on the ballot who has been
22 appointed by the county chairman of such political party, and the
23 challengers allowed by law. Voters having cast their ballots
24 shall at once retire without the seventy-five foot limit. A
25 person violating any provision of this notice is guilty of a
26 class 2 misdemeanor.

1 C. A minor voting in a simulated election at a polling place is
2 subject to the same seventy-five foot limit restrictions prescribed for a
3 voter. Persons supervising or working in a simulated election in which
4 minors vote may remain within the seventy-five foot limit of the polling
5 place. The inspector for the polling place shall exercise authority over all
6 election and simulated election related activities at the polling place.

7 D. For an election that is held by an Indian tribe and that is held at
8 a polling place at the same time and on the same date as any other election,
9 the following apply:

10 1. A person who is voting is subject to the same seventy-five foot
11 limit restrictions prescribed for other voters.

12 2. An election official for the tribal election may remain within the
13 seventy-five foot limit for the polling place.

14 E. With the permission of the voter, a minor may enter and remain
15 within the seventy-five foot limit in order to accompany a voter into a
16 polling place, an on-site early voting facility and a voting booth while the
17 voter is voting.

18 F. Notwithstanding any other law, an election official, a
19 representative of a political party who has been appointed by the county
20 chairman of that political party or a challenger who is authorized by law to
21 be within the seventy-five foot limit as prescribed by this section shall not
22 wear, carry or display materials that identify or express support for or
23 opposition to a candidate, a political party or organization, a ballot
24 question or any other political issue and shall not electioneer within the
25 seventy-five foot limit of a polling place.

26 G. NOTWITHSTANDING SECTION 16-1018, A PERSON MAY NOT TAKE PHOTOGRAPHS
27 OR VIDEOS WHILE WITHIN THE SEVENTY-FIVE FOOT LIMIT.

28 ~~G.~~ H. Any person violating this section is guilty of a class 2
29 misdemeanor.

30 ~~H.~~ I. For the purposes of this section, electioneering occurs when an
31 individual knowingly, intentionally, by verbal expression and in order to
32 induce or compel another person to vote in a particular manner or to refrain

1 from voting expresses support for or opposition to a candidate who appears on
2 the ballot in that election, a ballot question that appears on the ballot in
3 that election or a political party with one or more candidates who appear on
4 the ballot in that election.”
