SENATE AMENDMENTS TO S.B. 1432

(Reference to printed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Title 44, chapter 11, Arizona Revised Statutes, is amended  
3 by adding article 26, to read:

4 ARTICLE 26. INNKEEPER EMPLOYEES

5 44-1799.95. Employee guest room access; registered sex  
6 offenders prohibition; definition

7 A. AN INNKEEPER MAY NOT PERMIT AN EMPLOYEE WHO IS REQUIRED TO REGISTER  
8 AS A SEX OFFENDER PURSUANT TO SECTION 13-3821 OR THE LAWS OF ANOTHER STATE OR  
9 THE UNITED STATES DEPARTMENT OF JUSTICE TO HAVE ACCESS TO THE ROOM OF A  
10 REGISTERED GUEST OF THE INN.

11 B. AN INNKEEPER IS DEEMED TO HAVE PROVIDED OR PERMITTED ITS EMPLOYEE  
12 TO HAVE ACCESS TO THE ROOM OF A REGISTERED GUEST OF THE INN IF THE INNKEEPER  
13 EITHER:

14 1. ALLOWS AN EMPLOYEE TO POSSESS A KEY OR ANY OTHER MEANS OF UNLOCKING  
15 THE DOOR OR OTHER ENTRY TO THE ROOM OF A REGISTERED GUEST.

16 2. FAILS TO EMPLOY REASONABLE SAFEGUARDS TO PREVENT AN EMPLOYEE FROM  
17 OBTAINING POSSESSION OF A KEY OR ANY OTHER MEANS OF UNLOCKING THE DOOR OR  
18 OTHER ENTRY TO THE ROOM OF A REGISTERED GUEST.

19 C. BEFORE EMPLOYING A PROSPECTIVE EMPLOYEE, AN INNKEEPER MUST VERIFY  
20 THAT THE PROSPECTIVE EMPLOYEE WHO MAY BE PROVIDED ACCESS TO THE ROOM OF A  
21 REGISTERED GUEST OF THE INN IS NOT LISTED ON THE INTERNET SEX OFFENDER  
22 WEBSITE ESTABLISHED PURSUANT TO SECTION 13-3827 OR THE DRU SJODIN NATIONAL  
23 SEX OFFENDER PUBLIC WEBSITE ESTABLISHED PURSUANT TO 42 UNITED STATES CODE  
24 SECTION 16920. AFTER EMPLOYMENT, THE INNKEEPER SHALL VERIFY ANNUALLY THAT  
25 THE EMPLOYEE WHO MAY BE OR IS PROVIDED ACCESS TO THE ROOM OF A REGISTERED  
26 GUEST OF THE INN IS NOT LISTED AS A SEX OFFENDER ON THE INTERNET SEX OFFENDER  
27 WEBSITE ESTABLISHED PURSUANT TO SECTION 13-3827 OR THE DRU SJODIN NATIONAL

1           SEX OFFENDER PUBLIC WEBSITE ESTABLISHED PURSUANT TO 42 UNITED STATES CODE  
2           SECTION 16920.

3                   D. FOR THE PURPOSE OF THIS SECTION, "INN" INCLUDES A HOTEL, A BOARDING  
4           HOUSE, A LODGING HOUSE, AN APARTMENT HOUSE AND A MOTEL."
