FLOOR AMENDMENT EXPLANATION

The Smith Floor Amendment does the following:

- 1. Specifies that a county sheriff may provide written authorization to interact with Salt River horses for humane purposes only.**
- 2. Requires the Department of Agriculture (Department) to attempt to prove ownership of a horse with any brand or other mark indicating ownership before providing written authorization to interact with the Salt River horse herd.**
- 3. Requires the state to enter into an agreement with the United States Forest Service (Forest Service) in order to address any issue involving the Salt River horse herd.**
- 4. Specifies that the state may also enter into an agreement with a private entity to address issues involving the Salt River horse herd.**
- 5. Adds a conditional enactment clause that requires the Department to enter into an agreement with the Forest Service on or before December 31, 2017.**
- 6. Makes technical and conforming changes.**

7 A. The Arizona department of agriculture shall enter into an agreement
8 with the United States forest service pursuant to section 11-952, Arizona
9 Revised Statutes, to implement title 3, chapter 11, article 11, Arizona
10 Revised Statutes, as added by this act.

11 B. Title 3, chapter 11, article 11, Arizona Revised Statutes, as added
12 by this act, does not become effective unless the Arizona department of
13 agriculture and the United States forest service enter into an agreement
14 pursuant to subsection A of this section on or before December 31, 2017.

15 C. The Arizona department of agriculture shall notify in writing the
16 director of the Arizona legislative council on or before January 15, 2018
17 either:

- 18 1. Of the date on which the condition was met.
- 19 2. That the condition was not met."
