1 Page 1, line 4, strike "WILD"

2 Line 5, strike "wild"; strike "state property;"

3 Line 6, strike "violation" insert "violations"

4 Line 7, after "classification" insert ": definition"

5 Line 8, strike "WILD"; strike "PROPERTY" insert "AN ECONOMIC, RECREATIONAL AND
6 HISTORICAL ASSET"; strike "UNDER THE"

7 Strike line 9, insert ", AND THIS STATE SHALL HOLD THE HORSES IN TRUST FOR THE
8 PEOPLE OF THIS STATE."

9 Line 11, after "A" insert "PUBLIC OR"; strike "ACTIVE"; strike "WILD"

10 Line 14, strike "WILD"; after "HERD" insert "AND TO ESTABLISH A DESIGNATED AREA
11 ALONG THE SALT RIVER FOR THE SALT RIVER HORSE HERD THAT INCLUDES ENOUGH AREA
12 TO ALLOW THE SALT RIVER HORSE HERD TO MAINTAIN MIGRATION PATTERNS"

13 Between lines 14 and 15, insert:

14 "C. THE DIVISION MAY NOT:

15 1. AUCTION A HORSE THAT IS PART OF THE SALT RIVER HORSE HERD TO A
16 PERSON THAT SLAUGHTERS HORSES OR PROVIDES HORSES FOR SLAUGHTER. A CONTRACT
17 FOR THE SALE OF A HORSE THAT IS PART OF THE SALT RIVER HORSE HERD SHALL
18 INCLUDE A PROVISION THAT PROHIBITS THE BUYER FROM SLAUGHTERING THE HORSE OR
19 PROVIDING THE HORSE FOR SLAUGHTER.

20 2. MANAGE THE SIZE OF THE SALT RIVER HORSE HERD BY GELDING OR
21 OVARIECTOMY."

23 Line 16, strike "WILD"

1 Page 1, strike lines 18 and 19, insert:

2 "E. HORSES THAT ARE PART OF THE SALT RIVER HORSE HERD ARE NOT STRAY
3 ANIMALS AS DEFINED IN SECTION 3-1401 AND ARE NOT SUBJECT TO SECTION 3-1402."

4 Line 20, after "VIOLATES" insert "SUBSECTION C, PARAGRAPH 1 OR SUBSECTION D OF"
5 Strike lines 22 through 25, insert:

6 "G. A PERSON WHO CUTS, DESTROYS OR VANDALIZES FENCING USED TO PROTECT
7 THE SALT RIVER HORSE HERD IS GUILTY OF A CLASS 1 MISDEMEANOR.

8 H. FOR THE PURPOSES OF THIS SECTION, "MANAGEMENT" INCLUDES EFFORTS PUT
9 FORTH FOR THE BETTERMENT, HEALTH AND WELL-BEING OF THE SALT RIVER HORSE HERD,
10 TO PREVENT ABUSE OF THE SALT RIVER HORSES AND TO PROTECT THE PUBLIC, HEALTH
11 AND SAFETY.

12 3-1492. Unlawful release of a domesticated horse; violation;
13 classification

14 A PERSON WHO INTENTIONALLY RELEASES A DOMESTICATED HORSE INTO THE WILD
15 IS GUILTY OF A CLASS 1 MISDEMEANOR.

16 Sec. 2. Exemption from rulemaking

17 For the purposes of this act, the Arizona department of agriculture is
18 exempt from the rulemaking requirements of title 41, chapter 6, Arizona
19 Revised Statutes, for one year after the effective date of this act."
