FLOOR AMENDMENT EXPLANATION

- Specifies that the CPR instruction must include the hands-on practicing of cardiopulmonary resuscitation, except for those students enrolled in an online school
- Clarifies that a child with a disability can be excused from CPR training if that child's individualized education program team makes the determination to excuse that child.
- Adds a retroactivity clause to taxable years beginning January 1, 2016.
- Makes technical and conforming changes.
