SENATE AMENDMENTS TO S.B. 1321

1 Page 1, line 9, strike "MAY" insert "THAT OFFERS INSTRUCTION IN GRADES NINE THROUGH
2 TWELVE SHALL"; after "MENU" insert a period strike remainder of line
3 Strike line 10, insert "THE STATE BOARD OF EDUCATION SHALL ESTABLISH A PILOT
4 PROGRAM TO DEVELOP A MENU OF ASSESSMENTS FOR GRADES THREE THROUGH EIGHT BY
5 THE BEGINNING OF THE 2018-2019 SCHOOL YEAR."

6 Between lines 10 and 11, insert:

7 "B. A LOCAL EDUCATION AGENCY MAY APPLY TO THE STATE BOARD OF EDUCATION
8 FOR A SPECIAL WAIVER TO SELECT A STATEWIDE ACHIEVEMENT ASSESSMENT NOT ON THE
9 MENU OF STATEWIDE ACHIEVEMENT ASSESSMENTS. THE STATE BOARD OF EDUCATION SHALL
10 REVIEW THE SPECIAL WAIVER REQUEST AND MAY ONLY APPROVE SPECIAL WAIVER REQUESTS
11 FOR ASSESSMENTS THAT MEET THE REQUIREMENTS PRESCRIBED IN SUBSECTION F OF THIS
12 SECTION."

13 Reletter to conform

14 Line 24, after "SECTION" insert "EXCEPT THAT A LOCAL EDUCATION AGENCY ASSIGNED A
15 LETTER GRADE OF D OR F PURSUANT TO SECTION 15-241 MAY NOT CHOOSE AN
16 ASSESSMENT OTHER THAN THE ASSESSMENT ADOPTED BY THE STATE BOARD OF EDUCATION
17 PURSUANT TO SECTION 15-741 UNLESS THE SCHOOL OR SCHOOL DISTRICT RECEIVES
18 APPROVAL FROM THE STATE BOARD OF EDUCATION OR THE CHARTER SCHOOL RECEIVES
19 APPROVAL FROM ITS CHARTER SPONSOR."

20 Between lines 33 and 34, insert:

21 "4. DEMONSTRATE THAT THE ASSESSMENT SCORES CAN BE EQUATED FOR THE
22 PURPOSES OF ESTABLISHING AN ACHIEVEMENT PROFILE AND LETTER GRADE PURSUANT TO
23 SECTION 15-241."
