7 "1. "CHANGE OF USE" MEANS THE INTRODUCTION OF ADULT OFFENDERS OR
8 INMATES INTO A DEPARTMENT OF JUVENILE CORRECTIONS FACILITY OR THE
9 INTRODUCTION OF ADULT INMATES INTO ANY CORRECTIONAL FACILITY THAT HAD
10 PREVIOUSLY BEEN DESIGNATED AS A COMMUNITY CORRECTIONAL CENTER."
