HOUSE OF REPRESENTATIVES AMENDMENTS TO H.B. 2157

1 Page 1, line 5, strike "~~reasonable~~" insert "reasonable"

2 Line 6, strike "AT THE PRIVATE PROPERTY OWNER'S DISCRETION"

3 Between lines 7 and 8, insert:

4 "B. IF AN OWNER'S PRIVATE PROPERTY IS SURROUNDED BY LAND OWNED BY
5 THIS STATE OR ANY POLITICAL SUBDIVISION OF THIS STATE, THE OWNER OF THE
6 PRIVATE PROPERTY MAY REQUEST A RIGHT-OF-WAY FOR A TERM OF AT LEAST THIRTY
7 YEARS FROM THIS STATE OR ANY POLITICAL SUBDIVISION OF THIS STATE TO LEGALLY
8 ACCESS THE OWNER'S PRIVATE PROPERTY AT THE OWNER'S DISCRETION."

10 Line 9, strike "PERPETUAL"; after "RIGHT-OF-WAY" insert "FOR A TERM OF AT
11 LEAST THIRTY YEARS"

12 Line 10, strike "A PERPETUAL" insert "THE"

13 Line 11, after the first "TO" insert "THE OWNER'S"

14 Line 13, strike the comma insert "OR"; strike "OR THE FEDERAL"

15 Line 14, strike "GOVERNMENT"

16 Between lines 14 and 15, insert:

17 "D. FOLLOWING REASONABLE CONSULTATION WITH THE OWNER OF THE PRIVATE
18 PROPERTY, THIS STATE OR ANY POLITICAL SUBDIVISION OF THIS STATE SHALL
19 DETERMINE THE APPROPRIATE LOCATION AND WIDTH OF THE RIGHT-OF-WAY TO BE
20 GRANTED AND MAY RELOCATE THE RIGHT-OF-WAY AFTER THE GRANT AT THE DISCRETION
21 OF THIS STATE OR THE POLITICAL SUBDIVISION OF THIS STATE."

22 Reletter to conform

23 Line 15, after the second "THE" insert "PRIVATE"

1 Page 1, line 16, strike the first "REQUIRED" insert "NECESSARY TO PROVIDE LEGAL
2 ACCESS TO THE PRIVATE PROPERTY"

3 Strike lines 18 through 21, insert:

4 "F. A RIGHT-OF-WAY GRANTED PURSUANT TO THIS SECTION SHALL BE GRANTED
5 ACCORDING TO THE CONSTITUTION AND LAWS OF THIS STATE AND THE RULES ADOPTED
6 BY A STATE AGENCY, AS APPLICABLE."
