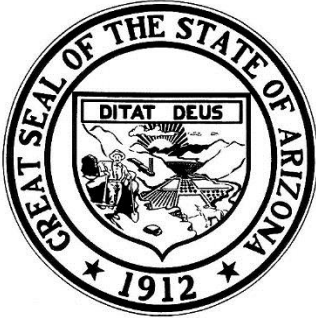


## HOUSE FLOOR AMENDMENT EXPLANATION



Bill Number: **HB 2331**

Campbell Floor Amendment

- 
- States the used motor vehicle dealer must be compensated by the manufacturer 15 days after the manufacturer has issued a notice of recall at a rate of 1.75%.
  - Requires the value of the used motor vehicle be the average of the trade-in value, rather than the retail value, determined by reference to a nationally recognized publication that reports on used motor vehicle values.
  - Requires all reimbursement claims be made in one of the following:
    - a. In the same manner as a warranty reimbursement;
    - b. At a rate set in a national compensation program that the manufacturer manages if the compensation provided to the dealer equals or exceeds the reimbursement level for a claim.
    - c. At the level set in the national compensation program if the manufacturer and dealer agree.

HOUSE OF REPRESENTATIVES AMENDMENTS TO H.B. 2331

I move the following SUBSTITUTE amendment to the TRANSPORTATION AND INFRASTRUCTURE Committee Amendment to HOUSE BILL 2331 (Reference to printed bill)

1 Page 5, line 44, after "DEALER" insert "THAT IS AUTHORIZED TO SELL NEW MOTOR  
2 VEHICLES OF THE SAME LINE-MAKE OF THE RECALLED MOTOR VEHICLE WITHIN FIFTEEN  
3 DAYS AFTER THE MANUFACTURER ISSUES THE NOTICE OF RECALL"

4 Line 46, strike "2.43" insert "1.75"

5 Page 6, line 4, after "VEHICLE" insert "THAT IS SUBJECT TO A STOP-SALE OR DO NOT  
6 DRIVE NOTIFICATION"; strike "RETAIL" insert "TRADE-IN"

7 Line 5, strike "INDICATED IN THE NATIONAL AUTOMOBILE DEALERS"

8 Strike lines 6 through 8, insert "DETERMINED BY REFERENCE TO A NATIONALLY  
9 RECOGNIZED PUBLICATION THAT REPORTS ON USED MOTOR VEHICLE VALUES."

10 Line 15, after "RECALL" insert "IF A STOP-SALE OR DO NOT DRIVE NOTIFICATION  
11 HAS BEEN ISSUED"

12 Line 20, after "MADE" insert "IN COMPLIANCE WITH AT LEAST ONE OF THE  
13 FOLLOWING:

14 1."

15 Line 21, after the period insert:

16 "2. AT A RATE SET FORTH IN A NATIONAL COMPENSATION PROGRAM THAT THE  
17 MANUFACTURER MANAGES IF THE COMPENSATION PROVIDED TO THE NEW MOTOR VEHICLE  
18 DEALER EQUALS OR EXCEEDS THE REIMBURSEMENT LEVEL FOR A CLAIM THAT IS  
19 DETERMINED AS A WARRANTY REIMBURSEMENT CLAIM PURSUANT TO PARAGRAPH 1 OF  
20 THIS SUBSECTION.
