1 Strike everything after the enacting clause and insert:

2 "Section 1. Title 41, chapter 7, article 12, Arizona Revised  
3 Statutes, is amended by adding section 41-1292, to read:

4 41-1292. Joint legislative oversight committee on the  
5 department of child safety; committee termination

6 A. THE JOINT LEGISLATIVE OVERSIGHT COMMITTEE ON THE DEPARTMENT OF  
7 CHILD SAFETY IS ESTABLISHED CONSISTING OF THE FOLLOWING MEMBERS:

8 1. THE CHAIRPERSON OF THE SENATE COMMITTEE THAT ADDRESSES CHILD  
9 SAFETY ISSUES.

10 2. THE CHAIRPERSON OF THE HOUSE OF REPRESENTATIVES COMMITTEE THAT  
11 ADDRESSES CHILD SAFETY ISSUES.

12 3. TWO MEMBERS OF THE SENATE WHO ARE APPOINTED BY THE PRESIDENT OF  
13 THE SENATE AND WHO ARE MEMBERS OF DIFFERENT POLITICAL PARTIES.

14 4. TWO MEMBERS OF THE HOUSE OF REPRESENTATIVES WHO ARE APPOINTED BY  
15 THE SPEAKER OF THE HOUSE OF REPRESENTATIVES AND WHO ARE MEMBERS OF  
16 DIFFERENT POLITICAL PARTIES.

17 B. THE CHAIRPERSON OF THE SENATE COMMITTEE THAT ADDRESSES CHILD  
18 SAFETY ISSUES AND THE CHAIRPERSON OF THE HOUSE OF REPRESENTATIVES COMMITTEE  
19 THAT ADDRESSES CHILD SAFETY ISSUES SHALL SERVE AS COCHAIRPERSONS.

20 C. THE COMMITTEE SHALL MEET AS OFTEN AS THE MEMBERS DEEM NECESSARY,  
21 AND A MAJORITY OF THE MEMBERS CONSTITUTES A QUORUM FOR THE TRANSACTION OF  
22 BUSINESS.

23 D. COMMITTEE MEETINGS ARE OPEN TO THE PUBLIC, AND THE COMMITTEE MAY  
24 NOT MEET IN EXECUTIVE SESSION.

25 E. THE COMMITTEE ESTABLISHED BY THIS SECTION ENDS ON JULY 1, 2025  
26 PURSUANT TO SECTION 41-3103."
