2 "Section 1. Laws 2014, chapter 15, section 5 is amended to read:

3 Sec. 5. Appropriation: department of veterans' services:
veterans' home facility: exemption

4 A. The sum of \$9,200,000 is appropriated from the state general fund
5 in fiscal year 2014-2015 to the department of veterans' services for
6 construction and establishment of a veterans' home facility in Yuma.

7 B. The amount appropriated in subsection A of this section is
8 intended to be this state's share of the costs, and is not subject to
9 expenditure for any purpose unless the department of veterans' services has
10 irrevocable commitments from the United States government for funding ~~at~~
11 ~~least sixty-five per cent~~ A PORTION of the total costs.

21 A. The sum of \$10,000,000 is appropriated from the state general
22 fund in fiscal year 2016-2017 to the department of veterans' services for

1 the establishment and construction of a veterans' home facility in
2 Flagstaff.

3 B. The amount appropriated in subsection A of this section is
4 intended to be this state's share of the costs of a veterans' home facility
5 in Flagstaff. The department may not spend the appropriation for any
6 purpose unless the department receives an irrevocable commitment from the
7 United States government to fund ~~at least sixty-five percent~~ A PORTION of
8 the total costs of a veterans' home facility in Flagstaff.

9 C. Before spending the appropriation in subsection A of this
10 section, the department of veterans' services shall submit the scope,
11 purpose and estimated cost of the veterans' home facility in Flagstaff to
12 the joint committee on capital review for its review pursuant to section
13 41-1252, Arizona Revised Statutes.

14 D. The appropriation made in subsection A of this section is exempt
15 from the provisions of section 35-190, Arizona Revised Statutes, relating
