FLOOR AMENDMENT EXPLANATION

- 1. States that emergency affidavits are not a public record.**
- 2. Allows an elector to update voter registration information when voting because of an emergency.**
- 3. Allows a county recorder or other officer in charge of elections to make changes to the approved emergency voting center location if an emergency voting center established by the county Board of Supervisors becomes unavailable and there is not sufficient time for the county Board of Supervisors to convene to approve an alternate location. The alternate emergency voting center must be as close in proximity to the approved emergency voting center location as possible.**
- 4. States that emergency voting takes place due to an emergency beginning at 5:00 PM the Friday preceding an election, rather than the second Friday preceding the election.**

10 ELECTIONS MAY MAKE CHANGES TO THE APPROVED EMERGENCY VOTING CENTER LOCATION
11 AND SHALL NOTIFY THE PUBLIC AND THE BOARD OF SUPERVISORS REGARDING THAT
12 CHANGE AS SOON AS PRACTICABLE. THE ALTERNATE EMERGENCY VOTING CENTER SHALL
13 BE AS CLOSE IN PROXIMITY TO THE APPROVED EMERGENCY VOTING CENTER LOCATION
14 AS POSSIBLE."
