

## HOUSE FLOOR AMENDMENT EXPLANATION



Bill Number: **HB 2893**

Kavanagh Floor Amendment

- 
1. Specifies that a local policy, rule or regulation must be *written* for a legislator to refer it to the Attorney General for investigation into whether it violates the law or state Constitution.
  2. Requires that, before a legislator may request the Attorney General investigate a written local policy, rule or regulation, the legislator must provide notice to the local entity and wait 60 days for possible repeal.

1 Page 4, line 16, after "revenues" insert ": notice of violation"

2 Line 20, after the first "ANY" insert "WRITTEN"; after the first comma insert  
3 "WRITTEN"; after the second "OR" insert "WRITTEN"

4 Line 29, after "order" insert ", WRITTEN POLICY, WRITTEN RULE"

5 Page 5, between lines 26 and 27, insert:

6 C. BEFORE A MEMBER OF THE LEGISLATURE MAY REQUEST AN INVESTIGATION  
7 BY THE ATTORNEY GENERAL OF ANY WRITTEN POLICY, WRITTEN RULE OR WRITTEN  
8 REGULATION ADOPTED BY ANY AGENCY, DEPARTMENT OR OTHER ENTITY OF A COUNTY,  
9 CITY OR TOWN PURSUANT TO SUBSECTION A OF THIS SECTION, THE MEMBER OF THE  
10 LEGISLATURE SHALL FIRST PROVIDE A WRITTEN NOTIFICATION OF THE ALLEGED  
11 VIOLATION OF STATE LAW OR THE CONSTITUTION OF ARIZONA TO THE CHIEF  
12 EXECUTIVE OFFICER OR GOVERNING BODY OF THE COUNTY, CITY OR TOWN. IF THE  
13 COUNTY, CITY OR TOWN DOES NOT REPEAL OR OTHERWISE RESOLVE THE VIOLATION  
14 WITHIN SIXTY DAYS AFTER RECEIVING THE NOTIFICATION, THE MEMBER OR MEMBERS  
15 OF THE LEGISLATURE MAY REQUEST AN INVESTIGATION BY THE ATTORNEY GENERAL  
16 PURSUANT TO THIS SECTION."
