

HOUSE FLOOR AMENDMENT EXPLANATION



Bill Number: **SB 1408**

Bowers Floor Amendment

-
1. Removes new language that states outlined requirements start *on a date determined by the department*.
 2. Requires DHS to develop a warning label that includes a statement that marijuana use may affect the health of a pregnant woman and the unborn child.
 3. Strikes language requiring DHS to develop warning labels that are based on the United States Department of Health and Human Services Office of the Surgeon General's warnings on marijuana.
 4. Requires DHS to require the labels to be affixed to the packaging of any marijuana or marijuana product that is sold by a marijuana establishment pursuant to statute related to responsible adult use of marijuana.
 5. Provides that the definitions for *marijuana*, *marijuana establishment* and *marijuana products* have the same meaning as prescribed in statute related to responsible adult use of marijuana.
 6. Directs DHS to provide grants from monies in the Medical Marijuana Fund for research, rather than meta-analyses, on the correlation between marijuana use and mental illness.
 7. Deletes language that exempts the grants from statutory requirements on the solicitation and award of grants.
 8. Instructs the DHS Director to make a one-time transfer of \$250,000, rather than a transfer of \$2,000,000, from the Medical Marijuana Fund to DHS to provide grants for marijuana research studies.
 9. Removes the emergency clause.
 10. Makes technical and conforming changes.
