**DIGEST:** This resolution designates a portion of State Route 36 near Susanville, from as the High Desert State Prison Correctional Officer Richard Bianchi, Jr., Memorial Highway.

**ANALYSIS:** This resolution designates a portion of State Route 36 near Susanville, from post mile 25.356 at State Route 139 to post mile R29.390 at Junction State Route 395, in the County of Lassen as the High Desert State Prison Correctional Officer Richard Bianchi, Jr., Memorial Highway. The Department of Transportation is requested to determine the cost of appropriate signage showing this special designation and, upon receiving donations from nonstate sources covering that cost, erect those signs.

**Background**

Officer Bianchi was killed in a single-vehicle crash in the early morning of June 25, 2020, while on his way to provide security coverage at a Redding

hospital. Officer Bianchi began his service with the Department of Corrections and Rehabilitation in 2010 after serving in the United States Air Force.

Officer Bianchi is survived by his wife, Pam, and two children, Richie and Rachel.
