A BILL FOR AN ACT

101 **CONCERNING THE CREATION OF CAREER PATHWAYS FOR STUDENTS**
102 **FOR CRITICAL OCCUPATIONS IN GROWING INDUSTRIES, AND, IN**
103 **CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Based upon the model developed for creating the manufacturing career pathway, the bill directs the state work force development council (state council) to coordinate multiple agencies and industries in the design of industry-driven career pathways for critical occupations in growing industries. The state council will work with partners through the talent

pipeline work group to define critical occupations and growing industries to determine which career pathways to design and in what order.

The bill includes the initial time frame for the development of career pathways and specifies that the first 3 career pathways will be in construction and related skilled trades, information technology, and health care. At least one career pathway must be designed and ready for implementation in the first year, and at least 2 career pathways must be created annually in subsequent years. The career pathways must include provisions that allow students to learn industry-related skills and obtain employment in the industry sector, including internship and apprenticeship opportunities, when relevant and available, as well as advance to higher levels of employment or education. The state council will provide outreach and training to agency partners and industries related to advising students on the career pathways.

The bill requires the state board of community colleges and occupational education to collaborate with the state council in the design of the career pathways and to use the development model created for the design of the manufacturing career pathway.

The bill requires information about the career pathway to be posted on-line.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** 24-46.3-104 as
3 follows:

4 **24-46.3-104. Career pathways - design - definitions - legislative**
5 **declaration.** (1) THE GENERAL ASSEMBLY HEREBY FINDS THAT CREATING
6 INDUSTRY-DRIVEN CAREER PATHWAYS FOR EDUCATION ASSISTS STUDENTS
7 IN ENTERING THE WORK FORCE AND PROVIDES INDUSTRIES WITH THE
8 TALENT PIPELINE NECESSARY TO FUEL COLORADO'S ECONOMY.
9 RECOGNIZING THE NEED FOR THE COORDINATED DEVELOPMENT OF
10 CAREER PATHWAYS FOR STUDENTS, THE GENERAL ASSEMBLY ENACTED
11 SECTION 24-46.3-103 IN 2014, TASKING THE STATE COUNCIL TO WORK
12 COLLABORATIVELY WITH THE DEPARTMENT OF HIGHER EDUCATION, THE
13 DEPARTMENT OF EDUCATION, THE DEPARTMENT OF LABOR AND
14 EMPLOYMENT, AND THE COLORADO OFFICE OF ECONOMIC DEVELOPMENT

1 TO CREATE THE TALENT PIPELINE DEVELOPMENT INFRASTRUCTURE FOR
2 USE IN CREATING CAREER PATHWAYS FOR STUDENTS. CREATING CAREER
3 PATHWAYS FOR GROWING COLORADO INDUSTRIES WITH OCCUPATIONS IN
4 HIGH DEMAND WILL:

5 (a) INCREASE THE NUMBER OF COLORADO CITIZENS ACCESSING
6 POSTSECONDARY EDUCATION AND APPRENTICESHIPS;

7 (b) INCREASE THE NUMBER OF COLORADO CITIZENS COMPLETING
8 DEGREES, APPRENTICESHIPS, AND OTHER CREDENTIALS;

9 (c) DECREASE THE NEED FOR REMEDIATION AT THE
10 POSTSECONDARY LEVEL;

11 (d) INCREASE ENTRY INTO EMPLOYMENT AND INCREASE WAGES
12 OVER TIME;

13 (e) CREATE BETTER TRANSITIONS FOR STUDENTS IN THE CAREER
14 PATHWAYS FROM HIGH SCHOOL, COMMUNITY COLLEGES, OR ADULT
15 EDUCATION PROGRAMS TO APPRENTICESHIPS, HIGHER EDUCATION, OR INTO
16 THE WORK FORCE;

17 (f) CREATE BETTER CONNECTIONS BETWEEN POSTSECONDARY AND
18 WORK FORCE READINESS INITIATIVES IN HIGH SCHOOL AND ADULT WORK
19 FORCE PROGRAMS; AND

20 (g) THROUGH PARTNERSHIPS WITH INDUSTRY, ASSIST STUDENTS IN
21 OBTAINING WORK EXPERIENCE AND EMPLOYMENT DURING AND AFTER
22 PARTICIPATION IN EDUCATIONAL PROGRAMS.

23 (2) AS USED IN THIS SECTION, UNLESS THE CONTEXT OTHERWISE
24 REQUIRES:

25 (a) "APPRENTICESHIP" MEANS A REGISTERED APPRENTICESHIP
26 PROGRAM WITH A WRITTEN PLAN THAT IS DESIGNED TO MOVE AN
27 APPRENTICE FROM A LOW- OR NO-SKILL ENTRY-LEVEL POSITION TO FULL

1 OCCUPATIONAL PROFICIENCY. THE PROGRAM MUST COMPLY WITH THE
2 PARAMETERS ESTABLISHED UNDER THE "NATIONAL APPRENTICESHIP
3 ACT", 29 U.S.C. 50, AS AMENDED, AND ITS PROMULGATING REGULATIONS,
4 AND ADMINISTERED BY THE UNITED STATE'S DEPARTMENT OF LABOR'S
5 OFFICE OF APPRENTICESHIP. AN INDIVIDUAL BUSINESS OR AN EMPLOYER
6 ASSOCIATION SPONSORS A REGISTERED APPRENTICESHIP AND MAY
7 PARTNER WITH A LABOR ORGANIZATION THROUGH A COLLECTIVE
8 BARGAINING AGREEMENT. UPON FINISHING A TRAINING PROGRAM, THE
9 APPRENTICE EARNS A "COMPLETION OF REGISTERED APPRENTICESHIP"
10 CERTIFICATE, WHICH IS AN INDUSTRY-ISSUED AND NATIONALLY
11 RECOGNIZED CREDENTIAL THAT VALIDATES PROFICIENCY IN AN
12 APPRENTICEABLE OCCUPATION.

13 (b) "CAREER PATHWAY" MEANS A SERIES OF CONNECTED
14 EDUCATION AND TRAINING STRATEGIES AND SUPPORT SERVICES THAT
15 ENABLE INDIVIDUALS TO SECURE INDUSTRY-RELEVANT SKILLS AND
16 CERTIFICATION WHERE APPLICABLE, TO OBTAIN EMPLOYMENT WITHIN AN
17 OCCUPATIONAL AREA, AND TO ADVANCE TO HIGHER LEVELS OF FUTURE
18 EDUCATION AND EMPLOYMENT.

19 (c) "CRITICAL OCCUPATIONS" MEANS TOP JOBS OR EMPLOYMENT
20 IN JOBS THAT LEAD TO TOP JOBS.

21 (d) "GROWING INDUSTRIES" MEANS INDUSTRIES THAT ARE
22 PROJECTED TO CREATE NEW JOBS ANNUALLY FOR AT LEAST THE NEXT TEN
23 YEARS.

24 (e) "PARTNERS" MEANS, AT A MINIMUM, STATE AGENCIES AND
25 ORGANIZATIONS DESCRIBED IN SECTION 24-46.3-103, THE STATE BOARD
26 FOR COMMUNITY COLLEGES AND OCCUPATIONAL EDUCATION CREATED IN
27 SECTION 23-60-104, C.R.S., AND INTERESTED POSTSECONDARY

1 **EDUCATION PROVIDERS.**

2 (f) "STATE COUNCIL" MEANS THE COLORADO WORK FORCE
3 DEVELOPMENT COUNCIL CREATED IN SECTION 24-46.3-101.

4 (g) "TOP JOBS" MEANS JOBS THAT HAVE STRONG PROJECTED
5 AVERAGE OPENINGS PER YEAR FOR TEN YEARS AND PAY A LIVING WAGE AS
6 DEFINED IN THE COLORADO TALENT PIPELINE REPORT PREPARED
7 PURSUANT TO SECTION 24-46.3-103.

8 (3) (a) THE STATE COUNCIL, IN COLLABORATION WITH ITS
9 PARTNERS AND AFTER CONSULTING WITH LOCAL WORK FORCE **BOARDS,**
10 **AND** A TASK FORCE WITHIN THE DEPARTMENT OF EDUCATION CONSISTING
11 OF LEADERSHIP FROM THE DEPARTMENT OF EDUCATION AND
12 **SUPERINTENDENTS OF LOCAL SCHOOL DISTRICTS,** SHALL DESIGN
13 INTEGRATED CAREER PATHWAYS FOR STUDENTS WITHIN INDUSTRY
14 SECTORS IDENTIFIED IN THE ANNUAL COLORADO TALENT REPORT
15 PREPARED PURSUANT TO SECTION 24-46.3-103 THAT ARE GROWING
16 INDUSTRIES AND THAT HAVE CRITICAL OCCUPATIONS THAT ARE WITHOUT
17 CLEARLY ARTICULATED CAREER PATHWAYS.

18 (b) (I) IN COLLABORATION WITH ITS PARTNERS PURSUANT TO
19 PARAGRAPH (a) OF THIS SUBSECTION (3), THE STATE COUNCIL SHALL:

20 (A) DESIGN AT LEAST ONE CAREER PATHWAY THAT IS READY FOR
21 IMPLEMENTATION BY OR BEFORE THE 2016-17 ACADEMIC YEAR FOR
22 CRITICAL OCCUPATIONS IN A GROWING INDUSTRY; AND

23 (B) DESIGN AT LEAST TWO CAREER PATHWAYS THAT ARE READY
24 FOR IMPLEMENTATION AT THE BEGINNING OF EACH SUBSEQUENT
25 ACADEMIC YEAR FOR CRITICAL OCCUPATIONS IN GROWING INDUSTRIES.

26 (II) BASED ON THE TOP JOBS LISTING IN THE TALENT PIPELINE
27 REPORT PREPARED IN JANUARY 2014, THE FIRST THREE GROWING

1 INDUSTRIES FOR DESIGN OF A CAREER PATHWAY ARE CONSTRUCTION AND
2 RELATED SKILLED TRADES, INFORMATION TECHNOLOGY, AND HEALTH
3 CARE.

4 (c) INDUSTRY, THROUGH REGIONAL SECTOR PARTNERSHIPS, AND
5 STATEWIDE TRADE ASSOCIATIONS SHALL REVIEW EACH CAREER PATHWAY
6 ANNUALLY TO ENSURE THAT THE CAREER PATHWAY REMAINS RELEVANT
7 TO THE INDUSTRY AND SHALL PROVIDE INPUT FOR ONGOING ADJUSTMENTS
8 TO THE CAREER PATHWAY TO MEET WORK FORCE NEEDS.

9 (d) CAREER PATHWAYS DESIGNED PURSUANT TO THIS SECTION
10 SHALL INCLUDE:

11 (I) APPRENTICESHIP AND OTHER WORK-BASED LEARNING OPTIONS
12 WHEN RELEVANT TO THE CAREER PATHWAY AND AVAILABLE IN THE
13 STATE;

14 (II) DIRECT ALIGNMENT WITH POSTSECONDARY AND WORK FORCE
15 READINESS AND INDIVIDUAL CAREER AND ACADEMIC PLANS IN HIGH
16 SCHOOLS. THE DEPARTMENT OF EDUCATION AND LOCAL SCHOOL DISTRICTS
17 THROUGH POSTSECONDARY AND WORK FORCE READINESS COORDINATORS
18 SHALL PARTNER WITH THE STATE COUNCIL TO ACHIEVE THE ALIGNMENT.

19 (III) INITIATIVES FOR ADULT AND OUT-OF-SCHOOL YOUTH WHEN
20 RELEVANT TO THE CAREER PATHWAY AND AVAILABLE.

21 (4) IN DESIGNING CAREER PATHWAYS, THE STATE COUNCIL SHALL:

22 (a) COORDINATE THE CAREER PATHWAY WORK GROUP MADE UP OF
23 ALL PARTNERS' SUBJECT MATTER EXPERTS TO ENSURE THAT CAREER
24 PATHWAYS ARE COMPREHENSIVE AND INTEGRATED ACROSS SECONDARY,
25 POSTSECONDARY, WORK FORCE, AND INDUSTRY EDUCATION AND
26 TRAINING PROGRAMS AND TO ENSURE THAT ALL PARTNERS ARE ENGAGED
27 IN THE DESIGN OF THE CAREER PATHWAYS; AND

1 (b) USE THE SECTOR PARTNERSHIP MODEL AND RELATIONSHIPS
2 WITH STATEWIDE TRADE ASSOCIATIONS TO ENSURE THAT ALL CAREER
3 PATHWAYS ARE INDUSTRY DRIVEN AND RELEVANT. A CAREER PATHWAY
4 SHALL NOT BE DESIGNED WITHOUT ACTIVE INDUSTRY ENGAGEMENT
5 THROUGHOUT THE PROCESS, FROM THE BEGINNING OF THE PROCESS
6 THROUGH THE FINAL CAREER PATHWAY THAT IS READY FOR
7 IMPLEMENTATION.

8 (5) THE STATE COUNCIL AND PARTNERS SHALL USE THE MODEL
9 DEVELOPED TO CREATE THE MANUFACTURING CAREER PATHWAY
10 PURSUANT TO SECTION 23-60-1003, C.R.S., INCLUDING ANY
11 IMPROVEMENTS TO THE MODEL BASED UPON THE IMPLEMENTATION OF THE
12 MANUFACTURING CAREER PATHWAY. CONSISTENT WITH THE
13 MANUFACTURING CAREER PATHWAY, CAREER PATHWAYS CREATED
14 PURSUANT TO THIS SECTION MUST HAVE THE COMPONENTS DESCRIBED IN
15 SECTION 23-60-1003 (2), C.R.S., AS THEY RELATE TO THE SPECIFIC CAREER
16 PATHWAY BEING CREATED.

17 (6) ONCE A CAREER PATHWAY IS COMPLETED PURSUANT TO THIS
18 SECTION, THE STATE COUNCIL SHALL FACILITATE OUTREACH AND
19 TRAINING RELATED TO ADVISING STUDENTS ON THE CAREER PATHWAYS
20 FOR ALL PARTNERS INVOLVED IN IMPLEMENTING THE CAREER PATHWAY,
21 AS WELL AS OTHER LOCAL, REGIONAL, OR STATE ENTITIES THAT ARE
22 INTERESTED IN PROMOTING THE CAREER PATHWAY TO STUDENTS.

23 (7) (a) ONCE A CAREER PATHWAY IS COMPLETED PURSUANT TO
24 THIS SECTION, THE STATE COUNCIL SHALL COLLABORATE WITH THE
25 DEPARTMENT OF HIGHER EDUCATION AND THE DEPARTMENT OF LABOR
26 AND EMPLOYMENT TO CREATE A MICROSITE CONCERNING THE CAREER
27 PATHWAY ON A STATE-PROVIDED, FREE ON-LINE RESOURCE. ■ ■ ■ AT A

1 MINIMUM, THE FOLLOWING INFORMATION MUST BE INCLUDED:

2 (I) INDUSTRY-SECTOR CAREER AWARENESS;

3 (II) SALARY AND WAGE INFORMATION FOR THE INDUSTRY-SECTOR
4 CAREER;

5 (III) THE INDUSTRY-SECTOR EMPLOYMENT FORECAST;

6 (IV) INFORMATION ON PROGRAMS WITHIN THE CAREER PATHWAY,
7 SERVICES PROVIDED, AND FINANCIAL AID OPPORTUNITIES FOR STUDENTS;

8 AND

9 (V) ON-LINE STUDENT SUPPORT SERVICES.

10 (b) THE STATE COUNCIL MAY USE MONEYS CREDITED TO THE
11 TALENT PIPELINE CASH FUND, CREATED IN SECTION 24-46.3-101, TO ADD
12 ADDITIONAL INFORMATION AND TOOLS TO A CAREER PATHWAYS
13 MICROSITE, SIMILAR TO THE INFORMATION AND TOOLS PROVIDED IN THE
14 MICROSITE RELATING TO THE MANUFACTURING CAREER PATHWAY.

15 **SECTION 2.** In Colorado Revised Statutes, 22-10-103, **amend**
16 (11) (b) (IV) as follows:

17 **22-10-103. Definitions.** As used in this article, unless the context
18 otherwise requires:

19 (11) (b) For purposes of this subsection (11), a postsecondary
20 education or training provider includes, but need not be limited to:

21 (IV) An entity that operates programs through the manufacturing
22 career pathway ~~established by the state board for community colleges and~~
23 ~~occupational education as provided in~~ PURSUANT TO part 10 of article 60
24 of title 23, C.R.S., OR ANOTHER CAREER PATHWAY PURSUANT TO SECTION
25 24-46.3-104, C.R.S.; and

26 **SECTION 3.** In Colorado Revised Statutes, **add** 23-60-109 as
27 follows:

1 **23-60-109. Career pathways - design - legislative declaration.**

2 (1) THE GENERAL ASSEMBLY FINDS AND DECLARES THAT:

3 (a) THE BOARD DEVELOPED THE MANUFACTURING CAREER
4 PATHWAY PURSUANT TO PART 10 OF THIS ARTICLE AFTER CONSULTING
5 WITH LOCAL DISTRICT JUNIOR COLLEGES AND AREA VOCATIONAL SCHOOLS,
6 AND IN COLLABORATION WITH THE DEPARTMENT OF LABOR AND
7 EMPLOYMENT, THE DEPARTMENT OF HIGHER EDUCATION, THE
8 DEPARTMENT OF EDUCATION, AND THE STATE WORK FORCE DEVELOPMENT
9 COUNCIL, CREATED IN SECTION 24-46.3-101, C.R.S.;

10 (b) THE MANUFACTURING CAREER PATHWAY WAS BASED UPON
11 GUIDELINES ENDORSED BY THE STATE WORK FORCE DEVELOPMENT
12 COUNCIL; AND

13 (c) THE KNOWLEDGE AND EXPERIENCE GAINED THROUGH THE
14 PROCESS OF DESIGNING AND IMPLEMENTING THE MANUFACTURING CAREER
15 PATHWAY SHOULD INFORM THE DESIGN AND IMPLEMENTATION OF
16 ADDITIONAL CAREER PATHWAYS PURSUANT TO SECTION 24-46.3-104,
17 C.R.S.

18 (2) THE BOARD SHALL COLLABORATE WITH THE STATE WORK
19 FORCE DEVELOPMENT COUNCIL TO DESIGN CAREER PATHWAYS PURSUANT
20 TO THE PROVISIONS OF SECTION 24-46.3-104, C.R.S. THE STATE WORK
21 FORCE DEVELOPMENT COUNCIL IS RESPONSIBLE FOR COORDINATING THE
22 DESIGN OF THE CAREER PATHWAYS. CAREER PATHWAYS DESIGNED
23 PURSUANT TO SECTION 24-46.3-104, C.R.S., MUST USE THE MODEL
24 DEVELOPED TO CREATE THE MANUFACTURING CAREER PATHWAY
25 PURSUANT TO SECTION 23-60-1003, INCLUDING ANY IMPROVEMENTS TO
26 THE MODEL BASED UPON THE IMPLEMENTATION OF THE MANUFACTURING
27 CAREER PATHWAY. CAREER PATHWAYS CREATED PURSUANT TO SECTION

2 23-60-1003 (2), AS THEY RELATE TO THE SPECIFIC CAREER PATHWAY
3 BEING CREATED.

4 **SECTION 4.** In Colorado Revised Statutes, **add** 23-18-308 as
5 follows:

6 **23-18-308. Fee-for-service contracts - limited purpose.**

7 (1) SUBJECT TO AVAILABLE APPROPRIATIONS, THE DEPARTMENT SHALL
8 ENTER INTO A FEE-FOR-SERVICE CONTRACT FOR THE FOLLOWING PURPOSE:

9 (a) (I) THE CREATION OF CAREER PATHWAYS FOR STUDENTS
10 PURSUANT TO SECTIONS 23-60-109 AND 24-46.3-104, C.R.S.

11 (II) NOTWITHSTANDING ANY PROVISION OF THIS PART 3 TO THE
12 CONTRARY, THE AMOUNT OF A FEE-FOR-SERVICE CONTRACT ENTERED INTO
13 PURSUANT TO THIS SECTION IS NOT INCLUDED IN THE CALCULATION OF
14 "TOTAL STATE APPROPRIATION" OR "TOTAL GOVERNING BOARD
15 APPROPRIATION" MADE PURSUANT TO THIS PART 3.

16 **SECTION 5. Appropriation.** (1) For the 2015-16 state fiscal
17 year, \$285,043 is appropriated to the department of labor and
18 employment for use by the division of employment and training. This
19 appropriation is from the general fund and is based on an assumption that
20 the division will require an additional 2.5 FTE. To implement this act, the
21 division may use this appropriation for the workforce development
22 council.

23 (2) For the 2015-16 state fiscal year, \$286,960 is appropriated to
24 the department of higher education. This appropriation is from the
25 general fund. To implement this act, the department may use \$200,000
26 for Colorado commission on higher education administration and
27 \$86,960 for college opportunity fund program fee-for-service contracts

1 with state institutions pursuant to section 23-18-308, C.R.S.

2 (3) For the 2015-16 state fiscal year, \$86,960 is appropriated to the
3 department of higher education. This appropriation is from
4 reappropriated funds received from the college opportunity fund program
5 fee-for-service contracts with state institutions under subsection (2) of
6 this section. To implement this act, the department may use this
7 appropriation for the state board for community colleges and
8 occupational education state system community colleges.

9 **SECTION 6. Act subject to petition - effective date.** This act
10 takes effect at 12:01 a.m. on the day following the expiration of the
11 ninety-day period after final adjournment of the general assembly
12 (August 5, 2015, if adjournment sine die is on May 6, 2015); except that,
13 if a referendum petition is filed pursuant to section 1 (3) of article V of
14 the state constitution against this act or an item, section, or part of this act
15 within such period, then the act, item, section, or part will not take effect
16 unless approved by the people at the general election to be held in
17 November 2016 and, in such case, will take effect on the date of the
18 official declaration of the vote thereon by the governor.
